 Provides relative to reinstatement fees for certain motor vehicle violations

Proposed law provides for increases in reinstatement fees for suspended licenses based on operating a motor vehicle while under the influence of alcohol or narcotics. Proposed law changes the reinstatement fee for a first offense fee from \$100 to \$150, for a second offense from \$200 to \$250, and for any subsequent offense from \$300 to \$350. Proposed law provides for increases in fees pursuant to the Consumer Price Index for All Urban Consumers (CPI-U) for the period beginning August 1, 2026, and ending January 31, 2028. Proposed law provides that beginning July 1, 2028, the OMV must make an annual adjustment to increase all the fees continued in present law and proposed law on an annual basis tied to the CPI-U.
