Excludes certain persons from participating in sports wagering. (8/1/26)

Proposed law provides that certain individuals are excluded from participating in sports wagering in the state. The measure establishes criteria for ineligibility and assigns responsibility for enforcement to licensed operators and the Louisiana Gaming Control Board (LGCB). Proposed law requires the LGCB to adopt rules to exclude persons who, before, during, or after a sporting event: threaten violence or harm against any participant in the event where the threat is related to sports wagering; or whose presence in a retail sportsbook or participation in mobile wagering is determined by the board to pose a threat to the interests of the state, to the intent and purpose of present law, or to the strict and effective regulation of sports wagering.

**EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure. Proposed law provides that certain individuals are excluded from participating in sports wagering in the state. Enforcement responsibility is assigned to licensed sports wagering operators, the Louisiana Gaming Control Board (LGCB), and the Louisiana State Police (LSP). The LGCB is required to adopt rules to exclude persons who threaten violence or harm related to sporting events or whose participation poses a threat to the integrity, intent, or effective regulation of sports wagering.

The process of placing individuals on exclusion lists is already underway using existing resources of the LGCB and LSP. Any administrative, compliance, or enforcement activities, including rule adoption, eligibility verification, and monitoring of excluded persons, can be absorbed within current staff and operational budgets, resulting in no anticipated increase in state expenditures.
