Provides for the Department of Transportation and Development to accept duties of the federal government. (8/1/26)

Proposed law allows the Department of Transportation and Development to take over certain federal transportation approval and environmental review duties; provides that the department make accept federal money from any agency of the federal government to carry the agreed upon federal duties.

EXPENDITURE EXPLANATION


Proposed law may result in an increase in Statutory Dedication (Transportation Trust Fund) expenditures and/or Federal Fund expenditures for the Department of Transportation and Development (DOTD), to the extent the department enters into an agreement with the federal government to assume the responsibilities of the United States Department of Transportation. The exact fiscal impact is indeterminable, as it is unknown what duties and responsibilities the department will take over. The department reports potential expenditures related to administrative, operational, and/or litigation associated with carrying out the expanded duties. Proposed law allows the department to accept and expend money received from the federal government for any transportation purpose. To the extent no federal funds are available for expanded duties, or funds are insufficient to cover the cost of the expanded duties, the department will utilize Transportation Trust Fund dollars.

REVENUE EXPLANATION

Proposed law authorizes the Department of Transportation and Development to receive federal funds, which may be used for any transportation purposes. The amount of federal funds that would be received is indeterminable.
