Subject: Reinstatement fees for lapses of vehicle liability security

Provides relative to reinstatement fees for lapses of vehicle liability security

Present law provides sanctions and reinstatement fees for a lapse in motor vehicle liability security. Present law requires a reinstatement fee for a lapse in vehicle security be \$100 per violation for lapses in coverage between one (1) to thirty (30) days. Proposed law reduces a reinstatement fee for a lapse in vehicle security from \$100 per violation to \$75 for lapses in coverage between one (1) to thirty (30) days. Present law requires a reinstatement fee for a lapse in vehicle security be \$250 per violation for lapses in coverage between thirty-one (31) to ninety (90) days. Proposed law reduces a reinstatement fee for a lapse in vehicle security from \$250 per violation to \$200 for lapses in coverage between thirty-one (31) to ninety (90) days. Present law requires a reinstatement fee for a lapse in vehicle security be \$500 per violation for lapses in excess of ninety (90) days. Proposed law reduces a reinstatement fee for a lapse in vehicle security from \$500 per violation to \$400 for lapses in coverage between in excess of ninety (90) days. Proposed law increases grace period before the imposition of a reinstatement fee.

EXPENDITURE EXPLANATION

Proposed law will require a one-time indeterminable SGR expenditure within the Department of Public Safety (DPS), Office of Motor Vehicles (OMV) to program and test software. The LFO believes that any additional IT work associated with this measure will be incremental in nature, and that the department can potentially accomplish these tasks utilizing existing resources and budget authority. To the extent that numerous pieces of legislation are enacted that require additional programming efforts, DPS may require additional resources.

While the proposed law does not otherwise directly impact state expenditures, it does reduce SGR and Statutory Dedications out of the Real Time Insurance Verification System Fund used to support certain functions within the Department of Public Safety, specifically a portion of State Police trooper salaries and the general operating costs of the Office of Motor Vehicles. To the extent that the legislature continues to fund activities in the Department of Public Safety supported by these revenues at the same or a diminished level in subsequent fiscal years, the funding sources supporting the base expenditures must be replaced by SGF or another revenue source to supplant the loss of SGR and statutory dedications. These activities would compete for annual SGF resources along with other significant SGF supported services and activities of the state.

REVENUE EXPLANATION

Proposed law will decrease self-generated revenues in the Department of Public Safety, Office of Motor Vehicles (OMV) as well as decrease revenues in the statutorily dedicated Real Time Insurance Verification System Fund as a result of reducing reinstatement fees on insurance cancellations as follows: from \$100 per violation to \$75 for lapses in coverage between one (1) to thirty (30) days; from \$250 per violation to \$200 for lapses in coverage between thirty-one (31) to ninety (90) days; and from \$500 per violation to \$400 for lapses in coverage between in excess of ninety (90) days. Monies from the Real Time Insurance Verification Fund are used within the Office of State Police for trooper salaries. SGR collected by OMV in excess of appropriation is deposited into the SGF.

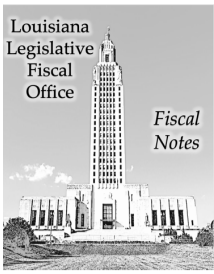
The potential loss in revenue from reinstatement fees is estimated at approximately \$24.6 M annually, including: \$22.1 M attributable to the reduction in the reinstatement fee; and \$2.5 M attributable to a reduction in OMV administrative fees. See Illustrative Tables on Page 2 for more details.
