AN ACT

To enact R.S. 46:450.5.1, relative to kidney disease; to provide for legislative intent; to provide for requirements for the Louisiana Department of Health; to provide for annual reviews; to provide for reporting; and to provide for related matters.

Be it enacted by the Legislature of Louisiana:

Section 1. R.S. 46:450.5.1 is hereby enacted to read as follows:

**§450.5.1. Chronic and rare kidney diseases; coverage; annual review**

**A. The legislature hereby finds that:**

**(1) More than thirty-five million Americans currently suffer from kidney disease and millions more may not be aware that they are at risk for developing kidney disease in the future.**

**(2) There is a new era emerging of clinical innovation in kidney disease treatment, with the first-ever treatments approved by the United States Food and Drug Administration to slow the decline of kidney function in patients with chronic and rare kidney diseases.**

**(3) Although the main causes of kidney disease are diabetes and high blood pressure, kidney disease also has genetic and hereditary causes, including**

1 rare diseases that cause glomerulonephritis.

2 (4) According to the Centers for Disease Control and Prevention, as  
3 many as nine out of ten Americans with chronic kidney disease are unaware  
4 they have it.

5 (5) If kidney disease is detected early through blood, urine, or other tests,  
6 it may be possible to slow its progression and delay the need for dialysis or  
7 transplant through lifestyle changes and pharmacological treatments.

8 (6) Dialysis and later stages of kidney disease are costly to the state and  
9 its healthcare system and often result in a patient leaving the workforce.

10 B. The legislature further finds that, considering the detrimental health  
11 effects of kidney disease in Louisiana and the United States, its enormous  
12 impact on the lives of patients and their caregivers, and the avoidable costs to  
13 the state, its workforce, and the healthcare system of undetected or  
14 undertreated kidney disease, it is in the interest of the state to encourage the  
15 prevention, early screening, diagnosis, treatment, disparity of impact, and  
16 overall awareness and understanding of kidney disease in Louisiana.

17 C.(1) The Louisiana Department of Health shall conduct an annual  
18 review of all medications and forms of treatment for chronic and rare kidney  
19 diseases and services for enrollees with a diagnosis of chronic or rare kidney  
20 disease that are eligible for coverage under Medicaid. The purpose of the annual  
21 review is to determine if the available covered medications, treatments, and  
22 services are adequate to meet the needs of enrollees with a diagnosis of chronic  
23 or rare kidney disease, and whether the department should seek to add  
24 additional medications, treatments, or services.

25 (2) When conducting the annual review required by this Subsection, the  
26 department shall solicit and consider input from the general public, with  
27 specific emphasis on attempting to receive input from persons or groups with  
28 knowledge and experience in the area of chronic and rare kidney diseases.

29 D. The department shall examine and pursue strategic partnerships with

1        state-based entities who represent or provide services to individuals living with  
 2        chronic and rare kidney diseases for the purpose of increasing education,  
 3        awareness, and diagnostic screening for chronic and rare kidney diseases,  
 4        through new or existing initiatives including but not limited to Well-Ahead  
 5        Louisiana.

6                E. On or before July 1, 2027, and on or before July first each year  
 7        thereafter, the department shall submit a report to the president of the Senate,  
 8        the speaker of the House of Representatives, the Senate Committee on Health  
 9        and Welfare, the House Committee on Health and Welfare, and the David R.  
 10        Poynter Legislative Research Library as required by R.S. 24:771 and 772. The  
 11        report shall detail the department's findings from the annual review required  
 12        by this Section, as well as any recommendations to the legislature based upon  
 13        the department's findings. The department shall publish the annual report on  
 14        its website in a manner accessible by the general public.

Proposed law provides legislative intent relative to the importance of prevention, early screening, diagnosis, and treatment of kidney disease.

Proposed law requires the La. Dept. of Health to conduct an annual review of all medications and forms of treatment for chronic and rare kidney diseases and services for enrollees with a diagnosis of chronic or rare kidney disease that are eligible for coverage under Medicaid.

Proposed law requires the department to examine and pursue strategic partnerships with state-based entities who represent or provide services to individuals living with chronic and rare kidney diseases for the purpose of increasing education, awareness, and diagnostic screening for chronic and rare kidney diseases.

Proposed law requires the department to submit an annual report to the Senate president, the speaker of the House, and the committees on health and welfare beginning July 1, 2027, that details the department's findings from the annual review and any recommendations to the legislature.

Effective August 1, 2026.
