9 resident of such parish, ~~or who may, instead of holding residency, be the chief~~
10 ~~executive officer of a business which is principally operated within each parish from~~
11 the list of nominees submitted to him by each of the following organizations:
12 (a) Louisiana Farm Bureau.
13 (b) Louisiana AFL-CIO.
14 (c) Southern University River Parishes Alumni Association.
15 (d) River Region Chamber of Commerce.

16 (4) One member shall be appointed by the governor from a list of one nominee each
17 from each parish located within the territorial jurisdiction of the port who is a
18 resident of such parish, ~~or who may, instead of residency, be the chief executive~~
19 ~~officer of a business which is principally operated from the list of nominees~~
20 submitted to him by each of the following organizations:
21 (a) River Parishes Chemical Industry Council.
22 (b) Grain Elevator and Processing Society.
23 (c) Greater New Orleans Barge Fleeting Association.

27 On page 1, delete lines 15 through 21 and insert the following:

28 " (5) ~~One member-at-large who shall reside and be domiciled within the~~
29 ~~geographical boundaries of the port shall be appointed by the governor. The person~~
30 ~~appointed shall be selected on the basis of his demonstrated experience in civic~~
31 ~~leadership and his ability and experience to act effectively for the best interest of the~~
32 ~~port and the state of Louisiana. Three members, one of whom is a resident of St.~~
33 ~~Charles Parish, one of whom is a resident of St. John the Baptist Parish, and one of~~
34 ~~whom is a resident of St. James Parish, shall be appointed by the governor at his sole~~
35 ~~discretion.~~

37 (6) ~~From the nominees submitted to the governor for appointment he shall select one~~
38 ~~resident from each parish located within the territorial jurisdiction of the port, one~~
39 ~~of whom may, instead of residency, be the chief executive officer of a business~~
40 ~~which is principally operated within such parish. In making appointments to the~~
41 ~~commission from among the nominees submitted to the governor as provided in~~
42 ~~Paragraphs (3), (4), and (5) of this Subsection, the governor shall appoint members~~
43 ~~in a manner to ensure that three of the members shall be residents of St. Charles~~

1 Parish, three shall be residents of St. John the Baptist Parish, and three shall be
