16 prevention strategies to develop a Louisiana Bullying Awareness and
17 Treatment Plan which provides, at a minimum, recommendations regarding
18 all of the following:

19 (a) Positive reforms to prevent bullying.

20 (b) Counseling and other treatment services for youths who are
21 victims of bullying as well as youths who are involved in bullying.

22 (c) Best practices for establishing a safe and healthy environment for
23 all children to learn, grow, and develop.

24 (2) The task force may render objective, fiscally feasible
25 recommendations to the legislature for the implementation of policies that
26 could be adopted by the state of Louisiana.

27 B.(1) With respect to developing bullying prevention policies and
28 procedures, the task force shall consider solutions and strategies that will
29 incorporate but not be limited to all of the following:

30 (a) A comprehensive statewide effort to fully identify and address
31 problem areas.

32 (b) A change in the environment to effectively combat bullying
33 behaviors.

34 (c) A change in the norms for behavior from students, educators,
35 parents, and others to successfully address the problem."
