**HOUSE FLOOR AMENDMENTS**

Amendments proposed by Representative Henry to Engrossed House Bill No. 1 by  
Representative Henry

1 AMENDMENT NO. 1

2 On page 12, between lines 2 and 3, insert the following:

3 "D. (1) Appropriations contained in this Act which are designated as  
4 "SUPPLEMENTARY BUDGET RECOMMENDATIONS" shall become effective in the  
5 event the official forecast for Fiscal Year 2016-2017 is revised to incorporate State General  
6 Fund (Direct) revenues over and above the official forecast of revenues available for  
7 appropriation on May 12, 2016.

8 (2) To the extent that additional revenues are available for appropriation, the additional  
9 revenues from State General Fund (Direct) shall be used to first fund the supplementary  
10 budget recommendations to the Department of Health and Hospitals, Medical Vendor  
11 Payments for the public private partnerships in the amount of \$71,930,619. In the event that  
12 the additional revenues are insufficient to fully fund such item contained in this Act  
13 designated as "SUPPLEMENTARY BUDGET RECOMMENDATIONS", the appropriation  
14 shall be reduced on a pro rata basis based upon the amount by which the additional revenues  
15 are insufficient to fully fund said appropriations.

16 (3) To the extent that additional revenues are available for appropriation above the  
17 forecast amount required to satisfy the appropriation requirement in Paragraph (2) of this  
18 Subsection, the additional revenues that are available for appropriation shall then be used  
19 to fund the supplementary budget recommendations to the Department of Health and  
20 Hospitals, Medical Vendor Payments from State General Fund (Direct) in the amount of  
21 \$60,797,191.

22 (4) The commissioner of administration is authorized to adjust other means of financing  
23 only to the extent necessary as a result of funding items contained herein from any  
24 supplementary budget recommendation."

26 AMENDMENT NO. 2

27 On page 14, line 34, change "Fees and Self-generated Revenues" to "Statutory Dedications  
28 out of the Tax Commission Expense Fund"

29 AMENDMENT NO. 3

30 On page 14, at the end of line 38, delete "Fees and Self-" and on line 39, delete "generated  
31 Revenues" and insert "monies in the fund"

32 AMENDMENT NO. 4

33 On page 37, line 19, after "allocated" and before "to support" insert "to the Northeast  
34 Louisiana Economic Alliance"

1 AMENDMENT NO. 5

2 On page 37, at the end of line 22, insert "Such allocation shall not be reduced in the event  
3 additional money is appropriated for regional economic development activities in the state."

4 AMENDMENT NO. 6

5 On page 57, between lines 46 and 47, insert the following:

6 "Provided, however, that of the monies appropriated herein to the Office of State Police,  
7 \$11,400,000 shall be transferred to the Governor's Office of Homeland Security and  
8 Emergency Preparedness for the Louisiana Wireless Information Network (LWIN) system."

9 AMENDMENT NO. 7

10 On page 72, after line 42, insert the following:

11 "Provided, however, that there shall not be any reductions to reimbursements for New  
12 Opportunities (NOW) Waivers.

14 In the event the official forecast for Fiscal Year 2016-2017 is revised to incorporate State  
15 General Fund (Direct) revenues over and above the official forecast of revenues available

37 On page 101, between lines 15 and 16, insert the following:

CODING: Words in ~~struck through~~ type are deletions from existing law; words underscored are additions.

1 "Notwithstanding any provision to the contrary, the Board of Regents, the Board of  
2 Supervisors for the University of Louisiana System, the Board of Supervisors of Louisiana  
3 State University and Agricultural & Mechanical College, the Board of Supervisors of  
4 Southern University and Agricultural and Mechanical College, the Board of Supervisors of  
5 Community and Technical Colleges, the Louisiana Universities Marine Consortium and the  
6 Office of Student Financial Assistance are authorized to transfer authorized positions from  
7 one budget unit to any other budget unit and/or between allocations or programs within any  
8 budget unit within higher education, subject to the approval of the Board of Regents and  
9 notification to the commissioner of administration and the Joint Legislative Committee on  
10 the Budget within 30 days. Such transfers shall be made to meet an immediate demand for  
11 research, instructional, and public service personnel or for direct patient care needs."
