
SENATE COMMITTEE AMENDMENTS

2016 Regular Session

Amendments proposed by Senate Committee on Transportation, Highways and Public Works to Original Senate Bill No. 400 by Senator Barrow

1 AMENDMENT NO. 1

2 On page 1, line 15, after "**apply to**" and before "**debt**" insert "**all**"

3 AMENDMENT NO. 2

4 On page 1, delete line 17 and insert the following:

5 **"32:863, including debt transferred to the Department of Revenue, office**
6 **of debt recovery, or the attorney general for collection, on the effective**
7 **date of this Section."**

8 AMENDMENT NO. 3

9 On page 2, delete lines 4 through 18 and insert the following:

10 **"(1)(a) The amnesty debt payment for fees charged for alleged**
11 **violations of R.S. 32:863(A)(1) that occurred on or before June 30, 2014,**
12 **shall not exceed fifty dollars per violation and at no time shall the total**
13 **amnesty debt payment for alleged multiple violations, including**
14 **administrative and collection fees, exceed five hundred dollars, when the**
15 **debtor pays the debt in full during the amnesty period and provides**
16 **proof of insurance on any vehicle registered in the debtor's name on the**
17 **date of the amnesty debt payment.**

18 **(b) The amnesty debt payment for fees charged for alleged**
19 **violations of R.S. 32:863(A)(1) that occurred on or after July 1, 2014,**
20 **shall not exceed one hundred dollars per violation and at no time shall**
21 **the total amount of debt for fees, including administrative and collection**
22 **fees, exceed eight hundred fifty dollars, when the debtor pays the debt**
23 **in full during the amnesty period and provides proof of insurance on any**
24 **vehicle registered in the debtor's name on the date of the amnesty debt**
25 **payment.**

26 **(c)The amnesty debt payment for fees charged for alleged**
27 **violations of R.S. 32:863(A)(2) that occurred on or before June 30, 2014,**
28 **shall not exceed fifty dollars per violation and at no time shall the total**
29 **amnesty debt payment for alleged multiple violations, including**
30 **administrative and collection fees, exceed five hundred dollars, when the**
31 **debtor pays the debt in full during the amnesty period and provides**
32 **proof of insurance on any vehicle registered in the debtor's name on the**
33 **date of the amnesty debt payment.**

34 **(d) The amnesty debt payment for fees charged for alleged**
35 **violations of R.S. 32:863(A)(2) that occurred on or after July 1, 2014,**
36 **shall not exceed one hundred dollars per violation and at no time shall**
37 **the total amount of debt for fees, including administrative and collection**
38 **fees, exceed one thousand seven hundred fifty dollars, when the debtor**
39 **pays the debt in full during the amnesty period and provides proof of**
40 **insurance on any vehicle registered in the debtor's name on the payment**
41 **date of the amnesty debt.**

42 **(2)(a) No amnesty payment for debt of a person sixty-five years**
43 **or older for alleged violations that occurred on or before June 30, 2014,**
44 **including administrative and collection fees, shall exceed two hundred**
45 **dollars.**

46 **(b) No amnesty payment for debt of a person sixty-five years or**
47 **older for alleged violations that occurred on or after July 1, 2014,**

1 including administrative and collection fees, shall exceed two hundred
2 fifty dollars.

3 (3) (a) No amnesty payment for a debtor who has alleged
4 violations of R.S. 32:863(A)(1) that occurred on or before June 30, 2014,
5 and on or after July 1, 2014, including administrative and collection fees,
6 shall exceed one thousand three hundred fifty dollars.

7 (b) No amnesty payment of a debtor who has alleged violations of
8 R.S. 32:863(A)(2) that occurred on or before June 30, 2014, and on or
9 after July 1, 2014, including administrative and collection fees, shall
10 exceed two thousand two hundred dollars."

11 AMENDMENT NO. 4

12 On page 2, after line 21, insert the following:

13 "F. (1) Prior to January 1, 2017, the office of motor vehicles shall
14 develop a debt amnesty program for collection of debts for failure to pay
15 a fee pursuant to either R.S. 32:57.1 or 863.1 and shall present such
16 program for approval to the House and Senate committees on
17 transportation, highways, and public works.

18 (2) Notwithstanding any provision of law to the contrary, prior
19 to July 1, 2017, the office of motor vehicles shall take no action to refer
20 to the office of debt recovery any debt which arises from a debtor's
21 failure to pay a fee pursuant to either R.S. 32:57.1 or 863.1 when the
22 debt was incurred prior to the effective date of the Act which originated
23 as Senate Bill No. 400 of the 2016 Regular Session of the Legislature."
