1 AMENDMENT NO. 1

2 On page 1, at the end of line 4, add the following:

3 "and to amend and reenact Section 4 of Act No. 191 of the 1926 Regular
4 Session of the Legislature, as amended by Act No. 294 of the 1938 Regular
5 Session of the Legislature, Act No. 120 of the 1946 Regular Session of the
6 Legislature, Act No. 307 of the 1948 Regular Session of the Legislature, Act
7 No. 17 of the 1956 First Extraordinary Session of the Legislature, Act No.
8 455 of the 1966 Regular Session of the Legislature, Act No. 105 of the 1976
9 Regular Session of the Legislature, and Act No. 303 of the 1977 Regular
10 Session of the Legislature, relative to the Northwest Louisiana Game and
11 Fish Preserve Commission;"

12 AMENDMENT NO. 2

13 On page 1, line 5, change "commission" to "commissions"

14 AMENDMENT NO. 3

15 On page 2, after line 5, add the following:

16 "Section 2. Section 4 of Act No. 191 of the 1926 Regular Session of
17 the Legislature, as amended by Act No. 294 of the 1938 Regular Session of
18 the Legislature, Act No. 120 of the 1946 Regular Session of the Legislature,
19 Act No. 307 of the 1948 Regular Session of the Legislature, Act No. 17 of
20 the 1956 First Extraordinary Session of the Legislature, Act No. 455 of the
21 1966 Regular Session of the Legislature, Act No. 105 of the 1976 Regular
22 Session of the Legislature, and Act No. 303 of the 1977 Regular Session of
23 the Legislature is hereby amended and reenacted to read as follows:

24 Section 4. There is hereby created the Northwest Louisiana Game and
25 Fish Preserve Commission, to be composed of five seven qualified electors
26 of the parishes of Natchitoches and Red River. ~~The police jury of each of~~
27 ~~these parishes shall appoint one qualified person to serve as a commissioner~~
28 ~~for said commission. At the initial meeting of the commission, the appointed~~
29 ~~commissioners shall elect three additional persons who shall be owners or~~
30 ~~operators of commercial fishing camps or commercial fishing establishments~~
31 ~~located in or on the Northwest Louisiana Game and Fish Preserve and~~
32 ~~qualified electors of either of the aforesaid parishes to serve as members of~~
33 ~~the commission. If the appointed members are unable to agree upon any~~
34 ~~person or persons to fill any or all of the remaining seats on the commission,~~
35 ~~they shall immediately communicate this fact to the secretary of the~~
36 ~~Louisiana Department of Wildlife and Fisheries, who shall then appoint a~~
37 ~~fully qualified person to each vacant seat on the commission. The governing~~
38 ~~authority of the parish of Natchitoches shall appoint five electors of~~
39 ~~Natchitoches Parish as members of the commission and the governing~~
40 ~~authority of the parish of Red River shall appoint two electors of Red River~~

1 Parish as members of the commission. Each commissioner shall serve a term
2 of four years, or until his successor is appointed and qualified. A vacancy on
3 the commission for any cause shall be filled in the same manner as the
4 original appointment and for the remainder of the unexpired term."
