WHEREAS, her social entrepreneurial and nonprofit experience with A's & Aces includes guiding the organization since its foundation, being responsible for the overall strategic planning, financial management, monitoring, evaluating, fundraising and grant-writing (contributed to raising over \$1,500,000 in cash and over \$1,000,000 of in-kind resources since 2008) and, in 2013 the organization was selected by the United States Tennis
