Amendments proposed by Senate Committee on Retirement to Engrossed House Bill No. 60 by Representative Miguez

1 AMENDMENT NO. 1

2 On page 1, line 2, after "reenact" delete the remainder of the line and insert "R.S. 11:710  
3 (A)(8) and (B)(1)(a) and (d) and to enact R.S. 11:710(A)(5)(d) and (9) and (B)(1)(e) and (f)  
4 relative"

5 AMENDMENT NO. 2

6 On page 1, line 11, after "R.S. 11:710(A)(8)" delete "is" and insert "and (B)(1)(a) and (d)  
7 are"

8 AMENDMENT NO. 3

9 On page 1, line 12, after "(9)" and before "are" insert "and (B)(1)(e) and (f)"

10 AMENDMENT NO. 4

11 On page 2, between lines 7 and 8, insert the following:

12 "B.(1)(a) Except as provided in Subparagraphs (e) and (f) of this Paragraph,  
13 Any any retired teacher who returns to active service covered by the provisions of  
14 this Chapter within the ~~twelve-month~~ thirty-six-month period immediately following  
15 the effective date of such retirement shall have his retirement benefits suspended for  
16 the duration of such active service or the lapse of ~~twelve~~ thirty-six months from the  
17 effective date of his retirement, whichever occurs first, even if such service is based  
18 on employment by contract or corporate contract.

20 (d) Except as provided in Subparagraphs (e) and (f) of this Paragraph, If if  
21 the reemployment of a retired teacher is based on an agreement between the retired  
22 teacher and his employer where such agreement was perfected prior to the retiree's  
23 effective date of retirement and where the agreement allows for the retiree to become  
24 reemployed within ~~twelve~~ thirty-six months immediately following the effective date  
25 of his retirement, the retiree shall not be eligible to receive retirement benefits for the  
26 ~~twelve-month~~ thirty-six-month period immediately following the effective date of  
27 such reemployment, regardless of whether such agreement is express or implied. The  
28 provisions of this Subparagraph shall be applied prospectively beginning on July 1,  
29 2001.

30 (e) Any retired teacher who returns to active service covered by the  
31 provisions of Paragraph (A)(4) of this Section within the twelve-month period  
32 immediately following the effective date of such retirement shall have his retirement  
33 benefits suspended for the duration of such active service or the lapse of twelve  
34 months from the effective date of his retirement, whichever occurs first, even if such  
35 service is based on employment by contract or corporate contract.

36 (f) Any person who has been retired for twelve months and who has returned  
37 to active service pursuant to the provisions of this Section prior to May 15, 2016,  
38 shall continue to be subject to the provisions of R.S. 11:710(B)(1)(a) and (d) in effect  
39 on June 30, 2016.
