2 On page 1, line 4, after "Program" and before the semicolon ";" insert "and for duties of the
3 Department of Health and Hospitals with respect thereto"

4 AMENDMENT NO. 2

5 On page 1, line 13, delete "of Louisiana"

6 AMENDMENT NO. 3

7 On page 1, line 16, delete "of Louisiana"

8 AMENDMENT NO. 4

9 On page 2, line 4, after "Hospitals" and before "in accordance" insert a comma "," and
10 "referred to hereafter in this Part as the "department","

11 AMENDMENT NO. 5

12 On page 2, at the end of line 7, change "cost" to "economically"

13 AMENDMENT NO. 6

14 On page 2, at the beginning of line 9, change "Medicaid eligible" to "Medicaid-eligible"

15 AMENDMENT NO. 7

16 On page 2, at the end of line 12, insert "The department may consider any other relevant
17 factors in its determination of which Medicaid recipients may participate in the Health
18 Insurance Premium Payment Program."

19 AMENDMENT NO. 8

20 On page 2, line 13, delete "HIPP recipients;" and insert in lieu thereof "Program
21 participants;"

22 AMENDMENT NO. 9

23 On page 2, line 14, after "department shall" delete the remainder of the line and delete line
24 15 in its entirety and insert in lieu thereof the following:

25 "inquire with each Medicaid applicant at the time of his application and with
26 each Medicaid enrollee at the time of his annual eligibility redetermination
27 whether he has an opportunity to"

29 On page 2, line 16, after "employer-sponsored" and before "insurance" insert "health"

2 On page 2, line 18, after "**those**" delete the remainder of the line and delete line 19 in its
3 entirety and insert in lieu thereof the following:

4 **"applicants and enrollees identified pursuant to the provisions of this Subsection**
5 **as having access to employer-sponsored health insurance coverage into such**
6 **coverage as soon as is practicable."**

9 **defined in R.S. 46:460.51,**"

13 On page 3, line 5, delete "**premium**" and insert in lieu thereof "**premiums**"
