3 insert "(C)(1) and (2)(a)(i) and (b)"

4 AMENDMENT NO. 2

5 On page 1, line 8, after "R.S. 33:2740.67(B) and" and before "are hereby" delete "(C)(1)(j)"
6 and insert "(C)(1) and (2)(a)(i) and (b)"

7 AMENDMENT NO. 3

8 On page 2, delete lines 16 through 19 in their entirety and insert the following:

9 (a) ~~Two members~~ One member shall be appointed by the state
10 representative for House District No. 29, ~~one of whom~~ who shall be a representative
11 of the business community.

12 (b) Two members shall be appointed by the state senator for Senate District
13 No. 15.

14 (c) One member shall be appointed by the mayor-president of the parish of
15 East Baton Rouge.

16 (d) One member shall be appointed by the member or members of the
17 governing authority of the parish of East Baton Rouge who represent the district.

18 (e) One member shall be appointed by the owner of the largest parcel of land
19 located within the district.

20 (f) One member shall be appointed by the state representative for House
21 District No. 61.

22 (g) One member shall be appointed by the state representative for House
23 District No. 63.

24 ~~(g)~~(h) One member shall be appointed by the state representative for House
25 District No. 67.

26 ~~(h)~~(i) One member shall be appointed by the state representative for House
27 District No. 101.

28 ~~(i)~~(j) One member shall be appointed by the state senator for Senate District
29 No. 14.

30 ~~(j)~~(k) ~~The branch manager of a bank~~ One urban designer or community
31 developer located within the district to be selected by a subcommittee formed by the
32 board.

33 ~~(k)~~(l) One representative of a civic association located within the district to
34 be selected by a subcommittee formed by the board.

35 (2)(a)(i) Members serving pursuant to Subparagraphs (1)(a) through ~~(i)~~(j) of
36 this Subsection shall serve four-year terms after initial terms as provided by Item (ii)
37 of this Subparagraph.

39 (b) Members serving pursuant to Subparagraphs ~~(i)~~(j) and ~~(k)~~ (l)(k) and (l)
40 of this Subsection shall serve at the pleasure of the subcommittee formed by the
41 board."
