TRAFFIC: (Constitutional Amendment) Provides relative to the use of traffic cameras

A JOINT RESOLUTION

Proposing to add Article VI, Section 10.1 to the Constitution of Louisiana, to prohibit the governing authority of a parish and local municipality from enacting any ordinance related to the installation and utilization of automated speed enforcement devices to regulate traffic on any local or parish road, or local, parish, or state highway; to provide for a definition; to provide for submission of the proposed amendment to the electors; to provide an effective date; and to provide for related matters. Section 1. Be it resolved by the Legislature of Louisiana, two-thirds of the members elected to each house concurring, that there shall be submitted to the electors of the state of Louisiana, for their approval or rejection in the manner provided by law, a proposal to add Article VI, Section 10.1 to the Constitution of Louisiana, to read as follows: §10.1. Traffic camera ordinances

Section 10.1.(A) Establishment. No governing authority of any local municipality or parish shall adopt, enact, or enforce any ordinance authorizing the use of automated speed enforcement devices to enforce compliance with traffic signals, traffic speeds, or other traffic laws, rules, or regulations on any public street, road, or highway within this state or impose or collect any civil or criminal fine, fee, or penalty for any such violation.

(B) Definitions. "Automated speed enforcement device" means a camera or optical device installed to work in conjunction with a traffic control signal or radar speed detection equipment, or both, and designed to record images that depict the

Be it further resolved that this proposed amendment shall be submitted 4 to the electors of the state of Louisiana at the statewide election to be held on October 14, 5 2017. 6 Section 3. Abstract: Prohibits the governing authority of any local municipality or parish from enacting ordinances authorizing the use of automated speed enforcement devices to regulate traffic. Provides a definition for automated speed enforcement device.

<u>Proposed constitutional amendment</u> prohibits the governing authority of any local municipality or parish from enacting ordinances authorizing the use of automated speed enforcement devices to regulate traffic on any public street, road, or highway.

<u>Proposed constitutional amendment</u> defines "automated speed enforcement device" as meaning a camera or optical device installed to work in conjunction with a traffic control signal or radar speed detection equipment, or both.

Provides for submission of the proposed amendment to the voters at the statewide election to be held Oct. 14, 2017.
