AGRICULTURE: Provides relative to animal control

1 AN ACT

2 To amend and reenact R.S. 3:2364 and 2365 and to repeal R.S. 3:2366, relative to the  
3 Louisiana Animal Control Advisory Task Force; to provide for the creation of the  
4 Louisiana Animal Control Advisory Task Force; to provide for task force  
5 membership and terms of office; to provide for the powers and duties of the state  
6 veterinarian in relation to the task force; to provide for the Louisiana Pet Registry;  
7 and to provide for related matters.

8 Be it enacted by the Legislature of Louisiana:

9 Section 1. R.S. 3:2364 and 2365 are hereby amended and reenacted to read as  
10 follows:

11 §2364. ~~Louisiana Animal Welfare Commission~~ Louisiana Animal Control Task  
12 Advisory Force

13 A. ~~Definition. For purposes of this Section, "animal" shall mean dogs and~~  
14 ~~cats.~~

15 B. ~~Creation and membership. (1) The Louisiana Animal Welfare~~  
16 ~~Commission is hereby created within the office of the governor for the purpose of~~  
17 ~~assisting the governor's office of community programs to ensure and promote the~~  
18 ~~proper treatment and well-being of animals. The commission shall receive no direct~~  
19 ~~funding from the state, but may receive incidental services from state agencies in~~  
20 ~~order to carry out its purpose.~~

1           ~~(2) Members of the commission shall serve four-year terms and shall not~~  
2           ~~receive any compensation or reimbursement of expenses. Each member of the~~  
3           ~~commission shall hold office until the appointment and qualification of his~~  
4           ~~successor. Whenever a vacancy occurs in an appointed position, the vacancy shall~~  
5           ~~be filled in the same manner and under the same terms and conditions as required for~~  
6           ~~the original appointment. The commission shall meet at the call of the chairman at~~  
7           ~~least quarterly and more often if necessary.~~

8           ~~(3) The executive director of the governor's office of community programs~~  
9           ~~or his designee shall be a member of the commission. Other members of the~~  
10          ~~commission shall be appointed by the governor in accordance with the following~~  
11          ~~provisions:~~

12           ~~(a) One representative of the Louisiana Department of Health.~~

13           ~~(b) One small animal veterinarian, appointed at large.~~

14           ~~(c) One member who is a director of a public animal control agency.~~

15           ~~(d) One commercial breeder of dogs.~~

16           ~~(e) Three representatives from separately operating humane societies or~~  
17          ~~private animal shelters.~~

18           ~~(f) One representative from the Louisiana State Police.~~

19           ~~(g) One member of the public, appointed at large.~~

20           ~~(h) Two representatives appointed from a list of five nominations submitted~~  
21          ~~by the Louisiana Veterinary Medical Association.~~

22           ~~(i) One representative of the Louisiana Quarterhorse Association.~~

23           ~~(j) One representative of the Louisiana Thoroughbred Breeders Association.~~

24           ~~(4) The governor shall appoint the initial chairman and initial vice chairman~~  
25          ~~of the commission from members appointed by the governor. Thereafter, the~~  
26          ~~members shall elect the chairman and vice chairman every odd-numbered year.~~

27           ~~(5) The domicile of the commission shall be in East Baton Rouge Parish.~~

28           ~~C. Transaction of business. A majority of the membership shall constitute~~  
29          ~~a quorum for the transaction of official business. All official actions of the~~

1       ~~commission shall require the affirmative vote of a majority of the members of the~~  
2       ~~commission.~~

3             ~~D. Duties and functions. The commission shall have powers and duties~~  
4       ~~necessary to carry out its purpose, including but not limited to the following:~~

5             ~~(1) To support local and municipal animal control enforcement efforts.~~

6             ~~(2) To support law enforcement in the investigation and prosecution of~~  
7       ~~animal cruelty cases.~~

8             ~~(3) To make recommendations concerning the care and keeping of animals.~~

9             ~~(4) To coordinate a statewide voluntary pet database that will assist animal~~  
10       ~~owners in recovering lost animals.~~

11            ~~(5) To provide a centralized public animal information, education, and~~  
12       ~~communication service.~~

13            ~~(6) To formulate and implement proposals to deal with pet overpopulation.~~

14            ~~(7) To make recommendations for rules and regulations, which may be~~  
15       ~~adopted by parish and local authorities for the proper care and treatment of animals.~~

16            ~~(8) To gather information from public records pertaining to the animals~~  
17       ~~within the purview of the commission. The government custodians of such records~~  
18       ~~shall make them accessible to the commission upon request under the provisions of~~  
19       ~~R.S. 44:1 et seq.~~

20            ~~(9) To inspect any animal impoundment facility for the purpose of making~~  
21       ~~recommendations to the appropriate governing authority for improvements to those~~  
22       ~~facilities and their operations wherever such facilities are operated by a government~~  
23       ~~animal control agency or designated by municipal or parish governments to be used~~  
24       ~~for the purpose of impoundment of animals. The governing authority shall provide~~  
25       ~~to the commission reasonable access to the facility, its records, and personnel within~~  
26       ~~seven days of receipt of a written request.~~

27            ~~(10) To request, in the form of a letter to the appropriate governing authority,~~  
28       ~~an animal control agency to produce public records pertaining to animal intake,~~  
29       ~~adoption, and euthanasia.~~

1           ~~(11) To establish and maintain the Louisiana Animal Shelter Registry.~~

2           ~~E. Louisiana Animal Welfare Fund. (1) The commission may accept and~~  
3           ~~solicit advice, services, and donations. Donations shall be remitted immediately to~~  
4           ~~the state treasury. After compliance with the requirements of Article VII, Section~~  
5           ~~9(B) of the Constitution of Louisiana relative to the Bond Security and Redemption~~  
6           ~~Fund, the monies shall be deposited in the Louisiana Animal Welfare Fund,~~  
7           ~~hereinafter referred to as the "fund", which is hereby created within the state treasury~~  
8           ~~and shall be used solely to carry out the functions and duties of the Louisiana Animal~~  
9           ~~Welfare Commission.~~

10           ~~(2) The commission shall maintain a checking account in a Louisiana~~  
11           ~~licensed banking establishment for holding and distributing money that may be~~  
12           ~~transferred from the fund to be used by the commission in fulfillment of its purposes.~~  
13           ~~The checking account shall be entitled "Louisiana Animal Welfare Commission".~~  
14           ~~It shall be held jointly in the names of the current chairman and treasurer of the~~  
15           ~~commission. All checks shall require joint signatures.~~

16           ~~(3) The treasurer of the state of Louisiana shall transfer monies from the fund~~  
17           ~~upon receiving a written order signed by the chairman and treasurer of the~~  
18           ~~commission. If the funds are insufficient to meet the full amount of the order, the~~  
19           ~~treasurer of the state of Louisiana may transfer the remaining balance in the fund.~~  
20           ~~The transfer of monies in the fund to the commission's checking account shall be~~  
21           ~~made within five business days of receiving the written order.~~

22           ~~(4) The financial records of the commission shall be maintained by the~~  
23           ~~treasurer of the commission. A copy of the records, jointly certified by the treasurer~~  
24           ~~and the chairman, shall be provided by the chairman to the legislative auditor for~~  
25           ~~inspection within twenty business days of the close of the state's fiscal year. The~~  
26           ~~legislative auditor shall report the findings of the inspection to the governor and the~~  
27           ~~chairman of the commission within ninety days of receiving the certified copy of the~~  
28           ~~records.~~

29           A. For purposes of this Section, the term "animal" shall mean a dog or cat.

1           B. The Louisiana Animal Control Advisory Task Force is hereby created  
2           within the office of the Louisiana Department of Agriculture and Forestry under the  
3           direction of the state veterinarian for the purpose of assisting community programs  
4           in ensuring and promoting the proper treatment and well-being of animals. The task  
5           force shall consist of the following five members to be appointed by the  
6           commissioner of agriculture:

7                   (1) One member who is a small animal veterinarian.

8                   (2) One member who is a director of a public animal control agency.

9                   (3) One representative from a private animal shelter.

10                  (4) One representative from the Louisiana Animal Control Association.

11                  (5) One representative from the Louisiana Veterinary Medical Association.

12           C. The state veterinarian shall have the powers and duties necessary to carry  
13           out its purpose, including but not limited to the following:

14                   (1) Support local and municipal animal control enforcement efforts.

15                   (2) Support law enforcement in the investigation and prosecution of animal  
16           cruelty cases.

17                   (3) Make recommendations concerning the care and keeping of animals.

18                   (4) Coordinate a statewide voluntary pet database that will assist animal  
19           owners in recovering lost animals.

20                   (5) Formulate and implement proposals to deal with animal overpopulation.

21                   (6) Promulgate rules and regulations that may be adopted by parish and local  
22           authorities for the proper care and treatment of animals.

23                   (7) Inspect animal impoundment facilities for the purpose of making  
24           recommendations to the appropriate governing authority for improvements to those  
25           facilities and their operations wherever such facilities are operated by a government  
26           animal control agency or designated by municipal or parish governments to be used  
27           for the purpose of impoundment of animals. The governing authority shall provide  
28           the state veterinarian, or his designee, with reasonable access to the facility, its  
29           records, and personnel within seven days of receipt of a written request.

1           (8) Submit written request to the appropriate governing authority to have its  
2           animal control agency produce public records pertaining to animal intake, adoption,  
3           and euthanasia.

4           D. The task force shall act in an advisory capacity to the state veterinarian  
5           and report activities periodically.

6           E.(1) Members of the task force shall serve at the pleasure of the appointing  
7           authority.

8           (2) The task force shall meet at least once per calendar year. Additional  
9           special or regular meetings may be held upon the call of the chairman.

10          (3) Task force members shall serve without compensation.

11          F. If the department does not receive the necessary funds, incurs a reduction  
12          in funds, or receives insufficient monies to fund or continue the program, the  
13          program shall become inactive.

14          §2365. Louisiana Pet Registry

15          ~~A. The Louisiana Animal Welfare Commission shall establish and maintain~~  
16          ~~a voluntary registry for animals called the Louisiana Pet Registry. The current owner~~  
17          ~~of any animal may register that animal with the commission.~~

18          ~~B.(1) The registration shall include the name and address of the owner and~~  
19          ~~the name and a description of the animal. If the animal has been fitted with a~~  
20          ~~microchip, the registration shall also include the brand of commercial microchip and~~  
21          ~~the animal's microchip identification number. If the animal is tattooed with an~~  
22          ~~identification number, the registration shall include the tattoo number.~~

23          ~~(2) The commission shall assign to each registered animal a unique~~  
24          ~~identification number and provide to the owner of each registered animal a license~~  
25          ~~tag bearing the identification number.~~

26          ~~(3) The manner in which the license number is affixed to the registered~~  
27          ~~animal is at the discretion of the owner.~~

28          ~~(4) The owner of each registered animal shall notify the commission of any~~  
29          ~~changes in registration information within thirty days.~~

1           ~~C. The owner of each registered animal shall pay a fee of fifteen dollars to~~  
2           ~~the commission for the registration of that animal.~~

3           ~~D. Fees shall be paid directly to the commission and deposited into the~~  
4           ~~Louisiana Animal Welfare Fund for use by the commission. The commission may~~  
5           ~~waive or reduce fees if it deems necessary.~~

6           ~~E. Applications for registration with the Louisiana Pet Registry shall be~~  
7           ~~made available by the commission. The commission shall provide public notices~~  
8           ~~pertaining to the registry.~~

9           The state veterinarian shall establish and maintain a voluntary registry for  
10          animals called the Louisiana Pet Registry. The current owner of any animal may  
11          register that animal with the registry.

12          Section 2. R.S. 3:2366 is hereby repealed in their entirety.

**Abstract:** Modifies provisions of law providing for the La. Animal Welfare Commission and the La. Animal Shelter Registry.

Present law provides for the La. Animal Welfare Commission (commission), which assists the governor's office of community programs with ensuring and promoting the proper treatment and well-being of animals by supporting local and municipal animal control efforts, making recommendations concerning the care and keeping of animals, and establishing the La. Animal Welfare Fund to be used solely to carry out the functions and duties of the commission.

Proposed law modifies present law by creating the La. Animal Control Advisory Task Force under the direction of the state veterinarian within the office of the La. Dept. of Agriculture and Forestry to ensure and promote the proper treatment and well-being of animals.

Proposed law specifies that the task force shall consist of five members appointed by the commissioner as follows: one member who is a small animal veterinarian, one member who is a director of a public animal control agency, one representative from a private animal shelter, one representative from the La. Animal Control Assoc., and one representative from the La. Veterinary Medical Assoc. Specifies that the members serve at the pleasure of the appointing authority. Specifies that members must serve without compensation. Further requires the task force act in an advisory capacity to the state veterinarian and report activities periodically.

Proposed law empowers the state veterinarian to carry out its purpose, including but not limited to the following: support local and municipal animal control efforts; support law enforcement in the investigation and prosecution of animal cruelty cases; make recommendations concerning the care and keeping of animals; coordinate a statewide pet database; formulate and implement proposals to deal with animal overpopulation; promulgate rules and regulations which may be adopted by parish and local authorities for the proper care and treatment of animals; inspect any animal impoundment facility for the purpose of making recommendations for improvement to those facilities and their operations to the appropriate governing authority under certain circumstances; and ability to request any animal control agency to produce public records pertaining to animal intake, adoption, and euthanasia.

Proposed law provides that if the department does not receive the necessary funds or receives insufficient monies to fund the program, the program will become inactive.

Present law provides for the La. Animal Shelter Registry, a voluntary animal shelter registry used by the commission to carry out its duties by requiring each parish to submit to the commission a list of all public animal shelters located within the parish's jurisdiction.

Proposed law repeals present law.

Present law provides for the La. Pet Registry. Requires the commission to establish and maintain a voluntary registry for animals, and provides that the current owner of any animal may register that animal with the commission. Further provides registration requirements, registration identification numbers, animal license tags and procedures for affixing the tag to the registered animal, notification of animal registration by the owner to the commission, a registration fee, directions for where the fees should be deposited, and where applications for registration and public notices pertaining to the registry must be provided.

Proposed law modifies present law by requiring the state veterinarian establish and maintain a voluntary registry for animals. Also, authorizes the current owner of any animal to register that animal.
