MTR VEHICLE/LICEN PLATES: Modifies the allocation of funding for the Support Our Troops special prestige license plate

AN ACT

2 To amend and reenact R.S. 46:122(A)(1) and R.S. 47:463.131(A), (B)(2), and (D), relative 3 to the Louisiana Military Family Assistance Fund; to provide relative to the Support 4 Our Troops special prestige license plate; to provide for the design of the license 5 plate; to provide for the license plate fee; and to provide for related matters. 6 Be it enacted by the Legislature of Louisiana: 7 Section 1. R.S. 46:122(A)(1) is hereby amended and reenacted to read as follows: 8 §122. Louisiana Military Family Assistance Fund 9 A.(1) Funds received by the state treasurer pursuant to the provisions of R.S. 10 47:120.31 and 306.3, or received by the treasurer or the Louisiana Military Family 11 Assistance Board from other public or private donations, gifts, grants, appropriations 12 or other revenue, including revenue derived from the Support Our Troops special 13 prestige license plate as provided for in R.S. 463.131, shall be deposited and credited 14 to a special fund hereby created in the state treasury to be known as the Louisiana 15 Military Family Assistance Fund. The money in the fund shall be used solely as 16 provided for in Subsection B of this Section. In addition to funds from any other 17 source, public or private donations, gifts, or grants from individuals, corporations, 18 nonprofit organizations, or other business entities may be made to the fund and 19 accepted by the fund for military family relief and assistance as provided in this Part. 20

2	read as follows:
3	§463.131. Special prestige license plates; Support Our Troops
4	A. The secretary of the Department of Public Safety and Corrections shall
5	establish a special prestige license plate to be known as the Support Our Troops
6	plate. He shall not require any minimum number of applicants prior to establishing
7	or issuing this plate. The license plate shall be restricted for passenger cars, pickup
8	trucks, vans, and recreational vehicles. The secretary shall design the plate, and it
9	shall bear the logo of a soldier and a child as developed by Support Our Troops, Inc.
10	and the words "Support Our Troops".

13	(2) Application for the Support Our Troops prestige license plate constitutes
14	prior written consent and instruction by the applicant to the department to provide
15	his name, address, and birth date to Support Our Troops, Inc. the Louisiana Military
16	Family Assistance Board. The secretary shall ensure that the application for the plate
17	includes a statement granting such consent.

**Abstract:** Reallocates money derived from the Support Our Troops special prestige licence plate to be placed in the La. Military Family Assistance Fund.

<u>Present law</u> provides for funds received pursuant to <u>present law</u> to be deposited to the La. Military Family Assistance Fund.

CODING: Words in struck through type are deletions from existing law; words <u>underscored</u> are additions.

<u>Proposed law</u> adds the revenue derived from <u>present law</u> to the funds deposited in the La. Military Family Assistance Fund.

<u>Present law</u> provides that the Support Our Troops special prestige licences plate bear the logo of a soldier and child developed by Support Our Troops Inc. and contain the words "Support Our Troops".

<u>Proposed law</u> removes the requirement that the plate contain the Support Our Troops, Inc. logo and requires the plate only contain the words "Support Our Troops".

<u>Present law</u> provides that application for the special prestige license plate constitutes prior consent to provide the name, address, and birth date of the applicant to Support Our Troops, Inc.

<u>Proposed law</u> modifies <u>present law</u> such that application for the special prestige license plate constitutes prior consent to provide the name, address, and birth date of the applicant to the La. Military Family Assistance Board.

Present law provides that the \$25 fee for the plate be forwarded to Support Our Troops, Inc.

<u>Proposed law</u> modifies <u>present law</u> by requiring the \$25 fee to be forwarded to the La. Military Family Assistance Fund.
