1 AMENDMENT NO. 1

2 On page 1, line 3, change "R.S. 9:5172(A)(3)" to "R.S. 9:5172(A)(3) and 5173.1"

3 AMENDMENT NO. 2

4 On page 1, line 4, after "requirements;" and before "and to provide" insert "to provide a form  
5 for partial cancellation of a mortgage;"

6 AMENDMENT NO. 3

7 On page 1, line 7, change "R.S. 9:5172(A)(3) is" to "R.S. 9:5172(A)(3) and 5173.1 are"

8 AMENDMENT NO. 4

9 On page 1, line 11, after "institution" and before "or duly" delete "executed before a notary  
10 public" and insert "represented by one of its officers and executed"

11 AMENDMENT NO. 5

12 On page 1, line 12, after "witnesses," and before "that" change "any act" to "or in any form"

13 AMENDMENT NO. 6

14 On page 2, at the beginning of line 28, delete "appeared"

15 AMENDMENT NO. 7

16 On page 3, at the beginning of line 1, delete "representatives, which declared" and insert  
17 "officer or officers, declares"

18 AMENDMENT NO. 8

19 On page 3, between lines 26 and 27, insert "[Choose one of the two following signature  
20 options.]"

21 AMENDMENT NO. 9

22 On page 3, line 27, change "PASSED" to "SIGNED"

23 AMENDMENT NO. 10

24 On page 4, after line 20, add the following:

25 "§5173.1. Mortgage or privilege partial cancellation by financial  
26 institution-standard form

27 A financial institution seeking a partial cancellation of a mortgage or  
28 privilege inscription pursuant to R.S. 9:5172 may use, and the recorder of mortgages  
29 for each and every parish in the state of Louisiana shall accept, the following form  
30 as fully compliant as a request for partial cancellation and act of partial release. The  
31 form contained in this Section is not the exclusive form to be accepted for filing, and

1 any other form meeting the requirements of R.S. 9:5172 may be used and filed to  
2 partially cancel the recordation of a mortgage or privilege:

3 REQUEST FOR PARTIAL CANCELLATION OF MORTGAGE OR PRIVILEGE  
4 AND PARTIAL RELEASE BY LICENSED FINANCIAL INSTITUTION  
5 PURSUANT TO R.S. 9:5172

32 The institution further expressly declares that the above-described mortgage  
33 or privilege is not released or cancelled as to any other property described in such  
34 mortgage or privilege, and such mortgage or privilege shall continue to encumber  
35 and remain in full force and effect as to all other property described therein.

36 The recorder of mortgages shall not be liable for any damages resulting to  
37 any person or entity as a consequence of partially cancelling a mortgage or vendor's  
38 privilege pursuant to this form.
