CONDOLENCES: Expresses condolences upon the death of Ralph R. Miller, former state representative

A RESOLUTION

2 To express the condolences of the House of Representatives upon the death of Ralph R. 3 Miller, former state representative. 4 WHEREAS, the members of the Louisiana House of Representatives were filled with 5 a great sense of loss and were saddened to learn that former state representative Ralph R. 6 Miller had passed from Earth to eternity on March 30, 2017, at the age of eighty-two; and 7 WHEREAS, Mr. Miller was a model of true citizenship: he was an attorney, a civic 8 leader, a former state representative, and a lobbyist; born and raised in Norco, Louisiana, he 9 never strayed far from his hometown roots; and 10 WHEREAS, a graduate of Destrehan High School, Louisiana State University, and 11 LSU Law School, Ralph Miller was a dedicated public servant who served twenty-two years 12 in the Louisiana House of Representatives; he was appointed chairman of the House 13 Committee on Administration of Criminal Justice and he also served as chairman of the 14 House Committee on Municipal, Parochial and Cultural Affairs; and 15 WHEREAS, Ralph Miller was one of a group of young legislators nicknamed the 16 "Young Turks" who, in the 1970s, achieved major reforms in the operation of the legislature; 17 the group is credited with having brought transparency and accountability to the legislative 18 process and pursued legislative independence from the gubernatorial and judicial branches 19 of state government; he also served as a member of the Council of the Louisiana State Law 20 Institute; and

1	WHEREAS, after blazing new trails in the Legislature of Louisiana, Mr. Miller
2	served as vice president of state governmental relations for Freeport McMoRan and held a
3	similar position with Crescent Technologies, where he worked until his death; Ralph Miller
4	was a lobbyist for twenty-five years; and
5	WHEREAS, Mr. Miller served as a member of the board of the Louisiana
6	Mid-Continent Oil and Gas Association, the Public Affairs Research Council, the New
7	Orleans Chamber of Commerce, the Bureau of Government Research, the World Trade
8	Center, the Council for a Better Louisiana, and the Louisiana Association of Business and
9	Industry; and
10	WHEREAS, his hometown always remained near and dear to Ralph Miller's heart,
11	and he was especially active in the civic affairs of Norco and St. Charles Parish; he received
12	several awards for his work in historic preservation, and he was a founding and lifelong
13	member and served as president of the River Road Historic Society; his lifelong passion was
14	the restoration of Destrehan Plantation; and
15	WHEREAS, the departure from this earthly realm of Ralph Miller deeply rends the
16	hearts of those who knew and loved him, but his memories will forever be cherished by his
17	beloved spouse of more than twenty-seven years, Sue Cutrer Miller; his children, Ross A.
18	Miller, Gregory A. Miller, who followed in his father's footsteps and was elected to the
19	office of state representative in 2011, and his wife Amy Pfrimmer, Maria C. Miller, and her
20	husband Michael Earle, and Maureen J. Miller; his brothers, Homer Miller, Jr., and his wife
21	Judy, D. James Miller, and his wife Sonia; his grandchildren, Candice Miller Catalano, and
22	her husband Anthony, Brooke Miller Bazile, and her husband Chase, Emma Miller Manson,
23	Kristin Rome Graebert, and her husband Eddie; his great-grandchildren; his father-in-law,
24	James H. Cutrer; and extended family, friends, and his Norco community; and
25	WHEREAS, the wonderful life of Ralph R. Miller will not be forgotten; family and
26	friends will fondly recall the hours Ralph spent on his favorite Florida beach balcony, where
27	he used loudspeakers to play John Philip Sousa marches and "National Anthems of the
28	World" to the delight or chagrin of those close by; his generosity, kindness, and humor, and
29	the hilarious stories of his nine lives, as well as his faithful friendship, will forever remain
30	in the minds of all who loved this exemplary citizen of Louisiana.
