Provides and clarifies the rights of law enforcement officers while under investigation. (gov sig)

Present law provides relative to the rights of law enforcement officers while under investigation and provides for pre-disciplinary hearings. Proposed law retains present law and further requires that the police under investigation be notified in writing of a pre-disciplinary hearing at least three days before it is scheduled. Present law provides that an investigation be considered complete upon notice of a pre-disciplinary hearing or determination of an unfounded or unsustained complaint. Proposed law provides that the investigation shall be considered complete upon conducting and completion of a pre-disciplinary hearing or a determination of an unfounded or unsustained complaint.

**EXPENDITURE EXPLANATION**

Proposed law may result in indeterminable, though likely marginal, increases in SGF and local funds expenditures. The proposed legislation requires written notice be delivered to a police employee or officer who is being investigated at least three days prior to the scheduling of a pre-disciplinary hearing. In the event a pre-disciplinary hearing is required, the State Police Commission would likely incur marginal administrative costs to produce and deliver a written notice that a hearing is being scheduled. In the event a pre-disciplinary hearing is required regarding a municipal police investigation, the same administrative costs would be borne by a local civil service board. However, because the number of written notices that may be issued is unknown, the exact cost increase is indeterminable, though expected to be marginal.

**REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
