Amendments proposed by House Committee on Health and Welfare to Original House Bill
No. 483 by Representative Jackson

1 AMENDMENT NO. 1

2 On page 1, line 2, delete "enact R.S. 40:1105.8.1," and insert in lieu thereof "amend and
3 reenact R.S. 40:1105.10(B) and to enact R.S. 40:5.12, 1105.8.1, and 1105.8.2,"

4 AMENDMENT NO. 2

5 On page 1, line 2, after "data" and before "by the" insert "on cancer"

6 AMENDMENT NO. 3

7 On page 1, line 7, after "functions;" and before "to establish" insert "to provide for state
8 cancer investigation and prevention functions;"

9 AMENDMENT NO. 4

10 On page 1, line 11, after "activities" delete the remainder of the line and insert in lieu thereof
11 "and data on cancer to designated"

12 AMENDMENT NO. 5

13 On page 1, line 12, after "parties;" and before "and to" insert "to provide for electronic
14 notifications and reports concerning cancer data;"

15 AMENDMENT NO. 6

16 On page 1, line 14, delete "R.S. 40:1105.8.1 is" and insert in lieu thereof "R.S.
17 40:1105.10(B) is hereby amended and reenacted and R.S. 40:5.12, 1105.8.1, and 1105.8.2
18 are"

19 AMENDMENT NO. 7

20 On page 1, between lines 14 and 15, insert the following:

21 "§5.12. Cancer investigation and prevention

22 A. Cancer prevention is hereby declared to be an urgent public health
23 priority of this state.

24 B. The state health officer and the office of public health of the Louisiana
25 Department of Health are hereby granted legislative authority to operate a program
26 of cancer investigation and prevention if sufficient funding is available for this
27 purpose.

28 C. The source of monies for the cancer investigation and prevention program
29 provided for in this Section may be any appropriation by the legislature, including
30 appropriations of federal funds, appropriations from the Health Excellence Fund
31 created by Article VII, Section 10.8(A)(2) of the Constitution of Louisiana, and
32 appropriations from the Louisiana Fund created by Article VII, Section 10.9(A) of
33 the Constitution of Louisiana; any public or private donations, gifts, or grants from
34 individuals, corporations, nonprofit organizations, or other business entities; and any
35 other monies which may be provided by law.

36 D. The state health officer and the office of public health of the Louisiana
37 Department of Health shall engage and collaborate with the Louisiana Tumor
38 Registry and the Louisiana Advisory Committee on Populations and Geographic

1 Regions With Excessive Cancer Rates in administering the cancer investigation and
2 prevention program provided for in this Section.

3 E. The program provided for in this Section shall be conducted in addition
4 to the activities of, and shall not replace or supplant, the Breast Cancer Control
5 Program provided for in R.S. 40:1105.13.

7 AMENDMENT NO. 8

8 On page 2, at the beginning of line 10, change "2" to "2(a)"

9 AMENDMENT NO. 9

10 On page 2, between lines 17 and 18, insert the following:

11 "(b) The tumor registry shall cooperate with the office of public health in
12 implementing the program of cancer investigation and prevention provided for in
13 R.S. 40:5.13."

14 AMENDMENT NO. 10

15 On page 4, line 8, delete "shall receive priority"

16 AMENDMENT NO. 11

17 On page 4, at the beginning of line 18, change "(4) The" to "(4)(a) Except as provided in
18 Subparagraph (b) of this Paragraph, the"

19 AMENDMENT NO. 12

20 On page 4, between lines 19 and 20, insert the following:

21 "(b) The tumor registry may release aggregate data for geographic areas
22 smaller than those provided in Subparagraph (a) of this Paragraph if requested by an
23 elected official serving in the legislative or executive branch of state government or
24 by the secretary of a department of the executive branch of state government."

25 AMENDMENT NO. 13

26 On page 6, after line 2, insert the following:

27 "§1105.8.2. Cancer data; electronic notifications and reports

28 The Louisiana Tumor Registry shall develop and publish on its website a
29 mechanism by which individuals may elect to receive in electronic format
30 notifications and reports issued by the tumor registry.

32 §1105.10. Annual cancer report

34 B. The ~~report~~ office of the president shall cause the report to be submitted
35 by March 31 ~~thirty-first~~ of each year to the governor, the speaker of the House of
36 Representatives, the president of the Senate, and the House and Senate Committees
37 on ~~Health and Welfare~~ health and welfare, and the governing body of each parish in
38 the state of Louisiana.
