Establishes a temporary permit fee for food and beverage vendors at fairs and festivals

<u>Proposed law</u> authorizes LA Department of Health (LDH), Office of Public Health (OPH) to charge a temporary fee of \$37.50 to each food and beverage vendor at the New Orleans Jazz and Heritage Festival. <u>Proposed law</u> is effective upon the signature of the governor or lapse of time for gubernatorial action.

EXPENDITURE EXPLANATION

There is no anticipated direct material effect on governmental expenditures as a result of this measure.

REVENUE EXPLANATION

The proposed legislation increases Fees and Self-Generated Revenues by \$2,813 in FY 18 and in future fiscal years within the Office of Public Health (OPH). The proposed legislation authorizes new temporary permit fee of \$37.50 on food vendors at the New Orleans Jazz and Heritage Festival. Presently, OPH assesses only a \$25 to permit the whole New Orleans Jazz and Heritage Festival. Under this measure, each food and beverage vendor at the festival will be required to pay a temporary permit fee of \$37.50. The new fee is project to generate \$2,813 annually ($$37.50 \times 75$ vendors = \$2,812.50).
