Amendments proposed by Senate Committee on Revenue and Fiscal Affairs to Original Senate Bill No. 241 by Senator Johns

1 AMENDMENT NO. 1

2 On page 1, line 2, after "To" delete the remainder of the line and insert in lieu thereof the
3 following:

4 "amend and reenact the introductory paragraphs of R.S. 47:302(AA) and
5 321.1(F)(66) and to enact R.S. 47:302(AA)(29) and 321.1(F)(66)(u), relative to state
6 sales and use tax; to provide"

7 AMENDMENT NO. 2

8 On page 1, line 8, after "Section 1." delete the remainder of the line and insert in lieu thereof
9 the following:

10 "The introductory paragraphs of R.S. 47:302(AA) and 321.1(F)(66) are hereby
11 amended and reenacted and R.S. 47:302(AA)(29) and 321.1(F)(66)(u) are hereby
12 enacted to read as follows:"

13 AMENDMENT NO. 3

14 On page 1, line 4, after "devices," delete the remainder of the line and insert in lieu thereof
15 the following:

16 "prostheses, restorative materials, and other dental devices; "

17 AMENDMENT NO. 4

18 On page 1, line 5, delete "connection with health care treatment;"

19 AMENDMENT NO. 5

20 On page 1, delete lines 11 through 17, and insert:

21 "AA. Notwithstanding any other provision of this Section to the contrary,
22 beginning July 1, 2016, **except Paragraph (29) of this Subsection**, the following
23 specific exclusions and exemptions shall be applicable to the tax levied pursuant to
24 the provisions of this Section:

25 * * *

26 **(29) Beginning October 1, 2017, sales and purchases of orthotic devices,**
27 **prosthetic devices, prostheses, restorative materials, and other dental devices**
28 **as provided in R.S. 47:305(D)(1)(t).**"

29 AMENDMENT NO. 6

30 On page 2, delete lines 9 through 14, and insert:

31 "(66) Beginning July 1, 2016, **except as provided in Subparagraph (u) of**
32 **this Paragraph**, in addition to those exclusions and exemptions provided for in
33 Paragraphs (1) through (65) of this Subsection, the following exclusions and
34 exemptions shall be allowable for purposes of the tax levied pursuant to the
35 provisions of this Section:

37 **(u) Beginning October 1, 2017, sales and purchases of orthotic devices,**
38 **prosthetic devices, prostheses, restorative materials, and other dental devices**
39 **as provided in R.S. 47:305(D)(1)(t).**"
