SPECIAL DAY/WEEK/MONTH: Recognizes Tuesday, May 9, 2017, as Ports Day at the state capitol

A RESOLUTION

2	To recognize Tuesday, May 9, 2017, as Ports Day at the state capitol.
3	WHEREAS, Louisiana has an abundant and robust port system ranging from ports
4	along the Mississippi, Calcasieu, Red, Atchafalaya, and Ouachita Rivers, the Louisiana
5	coast, and inland waterways extending to all areas of the state; and
6	WHEREAS, services provided at these ports help sustain local, regional, and
7	statewide economies; and
8	WHEREAS, Louisiana ports are also a point of connection between producers of
9	products in the state and buyers of products throughout the country and the world; and
10	WHEREAS, each port offers unique advantages and helps to encourage industrial
11	development, directly and indirectly providing jobs to local citizens and revenues to local
12	governments; and
13	WHEREAS, Louisiana's agricultural, petrochemical, food, paper, wood, and
14	fabricated metal products, which are dependant upon the state's ports, produce five hundred
15	twenty-five thousand Louisiana jobs, close to thirty-three billion dollars in personal earnings,
16	and over four billion dollars in state and local tax revenue; and
17	WHEREAS, Louisiana ports carry twenty-five percent of United States Waterborne
18	Commerce; and
19	WHEREAS, ports, tenants, and businesses serving ports produce seventy-seven
20	thousand jobs and over four billion dollars in personal earnings; and

1	WHEREAS, the state's ports have grown in assets by almost six-hundred million
2	dollars in the last decade; and
3	WHEREAS, to remain competitive, the Louisiana ports are planning approximately
4	ninety-two projects, with an estimated cost of one billion eight hundred million dollars over
5	the next five years; and
6	WHEREAS, the Louisiana Transportation Plan recommends an investment of over
7	seven billion dollars for port and channel improvement; and
8	WHEREAS, the Port Priority Program has significantly supported the building of
9	port infrastructure, and for every dollar invested in the program, the state of Louisiana
10	receives eight dollars in taxes, jobs, and economic benefits.
11	THEREFORE, BE IT RESOLVED that the House of Representatives of the
12	Legislature of Louisiana does hereby recognize Tuesday, May 9, 2017, as Ports Day at the
13	state capitol and does hereby express its appreciation for all of the ports that move Louisiana
14	forward.
15	BE IT FURTHER RESOLVED that a suitable copy of this Resolution be transmitted
16	to the Ports Association of Louisiana and to each port, harbor, or terminal district in the
17	state.
