2 On page 2, line 23, after "**Prohibited nation**" means" delete the rest of the line and delete  
3 line 24 and insert "**Iran, Sudan or Syria.**"

4 AMENDMENT NO. 2

5 On page 3, line 6, insert after "**A.**" insert the following:

6 **"On or before July 1, 2017, and every July first thereafter, the treasurer shall**  
7 **file a report with the legislature. The report shall include the following:**

8 **(1) A list of investments the treasurer has in companies with business**  
9 **operations that satisfy the criteria for investment in prohibited nations**  
10 **provided for in R.S. 39:100.151 including the issuer, and the name of the**  
11 **investment.**

12 **(2) A detailed summary of the business operations in prohibited**  
13 **nations of any company included on the list prepared pursuant to Paragraph**  
14 **(1) of this Subsection.**

16 On page 5, line 13, before "**The**" insert "**A.**"

17 AMENDMENT NO. 17

18 On page 5, between lines 14 and 15, insert the following:

19 **"B. The treasurer, in compliance with Subsection A of this Section,**  
20 **shall add or remove a nation from the list of prohibited nations, if the United**  
21 **States Department of State adds or removes that nation from the list of**  
22 **terror-sponsoring nations."**
