**HOUSE COMMITTEE AMENDMENTS**

2017 Regular Session

Amendments proposed by House Committee on Appropriations to Engrossed House Bill No. 528 by Representative Broadwater

1 AMENDMENT NO. 1

2 On page 1, line 2, after "To enact" delete the remainder of the line and at the beginning of  
3 line 3, delete "R.S. 17:1891 through 1894," and insert "R.S. 17:3129.2(H),"

4 AMENDMENT NO. 2

5 On page 1, line 4, after "education;" delete the remainder of the line and delete lines 5  
6 through 8 and insert "to provide relative to the outcome-based funding formula; to create the  
7 Public Postsecondary Education Funding Formula Panel; to require that such formula  
8 allocation be developed using audited data; to provide for annual review and approval of the  
9 formula application"

10 AMENDMENT NO. 3

11 On page 1, delete lines 11 through 20 and delete pages 2 and 3 and on line 4 delete lines 1  
12 through 3 and insert the following:

13 "Section 1. R.S. 17:3129.2(H) is hereby enacted to read as follows:  
14 §3129.2. Postsecondary education; outcomes-based funding formula;  
15 creation; components; approval; implementation; reports; review;  
16 hearings; approval

18 H.(1) The Public Postsecondary Education Funding Formula Panel,  
19 referred to in this Section as the "panel", is hereby created. The panel shall  
20 be composed of seven members. The president of each public postsecondary  
21 education system shall serve as an ex officio member of the panel, and one  
22 member shall be appointed by the governor, with consent of the Senate, one  
23 member shall be appointed by the Louisiana House of Representatives from  
24 the membership of the Louisiana Workforce Investment Council, and one  
25 member shall be appointed by the Louisiana Senate from the membership of  
26 the Louisiana Innovation Council. The governor's appointee shall serve as  
27 chairman of the panel.

28 (2) Upon the development of a preliminary formula allocation for the  
29 ensuing fiscal year, which shall be developed using audited data, the Board  
30 of Regents shall submit it to the panel not later than March thirty-first of each  
31 year.

32 (3) The commissioner of higher education shall convene public  
33 meetings pertaining to the preliminary formula allocation at which students,  
34 faculty, staff, administrators, management boards, and interested persons  
35 may appear and present testimony. The meetings shall be recorded and  
36 archived.

37 (4) The commissioner of higher education and the panel shall  
38 collaboratively and jointly review the preliminary formula allocation and  
39 consider public testimony delivered at the public meetings. A favorable vote  
40 of at least five panel members shall be required for approval of the formula  
41 allocation. If the panel approves the formula allocation, the Board of Regents  
42 shall adopt it at its June meeting and submit it to the Joint Legislative  
43 Committee on the Budget, the House Committee on Education, and the  
44 Senate Committee on Education not later than seventy-two hours prior to the  
45 final adjournment of the Regular Session of the Legislature. If the panel fails

1 to approve the formula allocation, the last formula allocation adopted by the  
2 board shall be used."
