| 4 | WHEREAS, Louisiana parents should have a wide range of high-quality school and |
| 5 | education options to choose from, be it traditional public schools, public charter schools, |
| 6 | private schools, or virtual learning; and |
| 7 | WHEREAS, the school choice program gives students, including those from |
| 8 | low-income families and those with special needs, the opportunity to receive tuition to attend |
| 9 | a private school of their choice; and |
| 10 | WHEREAS, the publicly funded Louisiana Scholarship Program empowers |
| 11 | low-income parents by providing them with the financial resources needed to send their |
| 12 | children to the school of their choice; and |
| 13 | WHEREAS, during fiscal year 2016-2017, six thousand six hundred ninety-five |
| 14 | students were able to utilize the Louisiana Scholarship Program in one hundred twenty-three |
| 15 | different schools within thirty-one school districts; and |
| 16 | WHEREAS, the average scholarship amount for a Louisiana Scholarship Program |
| 17 | recipient was five thousand eight hundred seventy-nine dollars; and |
| 18 | WHEREAS, the Tuition Donation Rebate Program empowers low-income Louisiana |

families with the financial resources to choose the school that will best prepare their children 1 2 for college and the workforce; and 3 WHEREAS, the Tuition Donation Rebate Program provides rebates to Louisiana 4 state taxpayers that donate to school tuition organizations, tax-exempt, not-for-profit organizations; and 5 6 WHEREAS, school tuition organizations use the donations to provide scholarships 7 to students in low-income families; and 8 WHEREAS, during fiscal year 2016-2017, one thousand six hundred ninety-two 9 students were able to take advantage of the Tuition Donation Rebate Program; and 10 WHEREAS, the average scholarship amount for the program recipient was four 11 thousand one hundred thirty-seven dollars; and WHEREAS, since first launched in New Orleans in 2008 and expanded statewide in 12 13 2012, the Louisiana Scholarship Program has assisted thousands of Louisiana families in 14 choosing a school that best fits the needs of their children. 15 THEREFORE, BE IT RESOLVED that the Legislature of Louisiana does hereby recognize Tuesday, May 16, 2017, as "School Choice Day" at the Louisiana State Capitol 16 and encourage all Louisianians to learn more about school choice programs. 17 18 BE IT FURTHER RESOLVED that a copy of this Resolution be transmitted to the 19 Louisiana state president of the American Federation for Children.
