14	WHEREAS, "Wine Up at the Village", a wine-tasting and appetizers festival in the
15	historic Le Vieux Village area to be held on Thursday, June 8, 2017, continues The Walking
16	Ladies' goal of raising funds for Opelousas lighting enhancements; proceeds from this event
17	will also be used to fund a Nativity scene on the courthouse square; and
18	WHEREAS, The Walking Ladies now includes a fifth member, Marguerite
19	Thisthlethwaite Bordelon; it is appropriate to commend the civic pride these women have
20	displayed in lighting up downtown Opelousas.
