To require that parents be provided with information regarding the public health risk associated with pornography and access to information on prevention. (8/1/18)

**Present law** requires school districts to adopt policies regarding access by students and employees to internet and online sites that contain or make reference to harmful material that is believed to be obscene, pornographic, conducive to hostile or dangerous school environment, violent, or sexually harassing, including the use of computer related technology or internet service provider technology designed to block access or exposure. **Proposed law** further requires the Department of Education to compile a handout regarding the public health risks and harm associated with pornography including resources available to parents regarding child safeguards and free internet filters; delineates information to be included. Requires the department to disseminate the handout to each public elementary and secondary school for distribution to the parent of each student.
