1 AN ACT

2 To amend and reenact R.S. 33:9091.12(F)(4)(b)(i) as amended by Act No. 372 of the 2017
3 Regular Session of the Legislature, relative to the Upper Audubon Security District
4 in Orleans Parish; to provide relative to the parcel fee levied within the district; to
5 provide relative to the renewal of such fee; and to provide for related matters.

6 Notice of intention to introduce this Act has been published
7 as provided by Article III, Section 13 of the Constitution of
8 Louisiana.

9 Be it enacted by the Legislature of Louisiana:

10 Section 1. R.S. 33:9091.12(F)(4)(b)(i) as amended by Act No. 372 of the 2017
11 Regular Session of the Legislature is hereby amended and reenacted to read as follows:

12 §9091.12. Upper Audubon Security District

18 (b)(i) ~~The~~ Except as provided in Item (ii) of this Subparagraph, the fee shall
19 expire at the time provided in the proposition authorizing the fee, not to exceed seven
20 years from its initial imposition, but the fee may be renewed as provided in

1 Subparagraph (a) of this Paragraph. Any election to authorize the renewal of the fee
 2 shall be held only at the same time as ~~the mayoral primary election for~~ a regularly
 3 scheduled election in the city of New Orleans. If renewed, the term of the imposition
 4 of the fee shall be provided in the proposition authorizing such renewal, not to
 5 exceed seven years.

Abstract: Provides relative to the parcel fee levied within the Upper Audubon Security District in Orleans Parish.

Present law creates the Upper Audubon Security District in Orleans Parish as a political subdivision to aid in crime prevention and reduction by providing additional security for district residents.

Proposed law retains present law.

Present law authorizes the governing authority of the city of New Orleans to impose a parcel fee on behalf of the district, subject to voter approval. Proposed law retains present law.

Present law authorizes renewal of the fee, subject to voter approval, and requires the election for renewal of the fee to be held at the same time as a regularly scheduled election in the city of New Orleans.

Secs. 2 of Act No. 372 of the 2017 RS (effective Jan. 1, 2019) requires the election for renewal of the fee to be held only at the same time as the mayoral primary election for the city of New Orleans. Proposed law instead requires that the election for renewal be held at the same time as a regularly scheduled election in the city of New Orleans.

Effective January 2, 2019.
