**EXPENDITURE EXPLANATION**

The proposed legislation will result in an indeterminable increase in SGF expenditures. According to the LSLI the costs can range from \$0 to \$3,500 annually plus parking and round-trip mileage reimbursement of 54.5 cents per mile. Additionally, the maximum number of meeting per fiscal year is 8. However, the fiscal impact will depend upon the number of meeting days in attendance and the domicile of the new member. Based on the state travel regulations (PPM 49), the maximum costs for lodging and meal allowances due to the per day reimbursement rates are shown below:
