HEALTH: Provides relative to the Louisiana Licensed Professional Vocational Rehabilitation Counselors Board of Examiners

1	AN ACT
2	To amend and reenact R.S. 37:3444(A) through (C) and 3445(D), relative to the Louisiana
3	Licensed Professional Vocational Rehabilitation Counselors Board of Examiners; to
4	revise the name of a professional association referred to in laws relative to the board;
5	to provide for the adoption of a code of professional ethics; and to provide for related
6	matters.
7	Be it enacted by the Legislature of Louisiana:
8	Section 1. R.S. 37:3444(A) through (C) and 3445(D) are hereby amended and
9	reenacted to read as follows:
10	§3444. Louisiana Licensed Professional Vocational Rehabilitation Counselors
11	Board of Examiners
12	A. There is hereby created in the Louisiana Department of Health the
13	Louisiana Licensed Professional Vocational Rehabilitation Counselors Board of
14	Examiners, hereafter referred to as the "board", consisting of five members, who
15	shall be residents of the state of Louisiana. The members shall be appointed by the
16	governor from a list of qualified candidates supplied by the Louisiana International
17	Association of Rehabilitation Professionals Professionals-Louisiana, as specified in
18	this Section. within sixty days after July 14, 1988, to serve the following terms: one
19	member for a term of two years, two members for terms of three years, and two
20	members for terms of four years. Thereafter, each Each term shall be for four years.

1 Each appointment by the governor shall be submitted to the Senate for confirmation. 2 B. The membership of the board shall consist of three licensed professional 3 vocational rehabilitation counselors and two individuals from the public at large. 4 The original professional membership of the board shall be qualified to be licensed 5 under this Chapter, except that the initial professional members shall be persons who 6 have rendered rehabilitation counseling for at least three years. Within thirty days 7 after July 14, 1988, the executive committee of the Louisiana Association for 8 Rehabilitation Professionals shall submit to the governor a list of qualified 9 candidates for the board. The board shall perform such duties and exercise such 10 powers as this Chapter prescribes and confers upon it. No member of the board shall 11 be individually liable for any act or omission resulting in damage or injury arising 12 out of the exercise of his judgment in the formation and implementation of policy 13 while acting as a member of the board, provided he was acting in good faith and 14 within the scope of his official functions and duties, unless the damage or injury was 15 caused by his willful or wanton misconduct.

16 C. No board member shall serve more than two full consecutive terms. 17 Subsequent appointments to the board shall be made in the manner of the original 18 appointments, including the submission of by the governor from a list of qualified 19 candidates by the executive committee of the Louisiana Association for International 20 Association of Rehabilitation Professionals Professionals-Louisiana. Any board 21 member may be removed by the governor or majority vote of the board, after notice 22 and hearing, for incompetence, neglect of duty, malfeasance in office, or moral 23 turpitude. Any vacancy occurring in board membership, other than by expiration of 24 term, shall be filled for the remainder of the unexpired term by the governor within 25 thirty days from a list of qualified candidates supplied by the Louisiana Association 26 for International Association of Rehabilitation Professionals Professionals-Louisiana.

Abstract: Revises the names of professional associations referred to in laws relative to the La. Licensed Professional Vocational Rehabilitation Counselors Board of Examiners.

<u>Present law</u> creates the La. Licensed Professional Vocational Rehabilitation Counselors Board of Examiners. Provides that the members of the board are appointed by the governor from a list of candidates supplied by the La. Association of Rehabilitation Professionals.

<u>Proposed law</u> retains <u>present law</u> and updates the name of the professional association which supplies the list of candidates for the board <u>from</u> La. Association of Rehabilitation Professionals to International Association of Rehabilitation Professionals-La.

<u>Present law</u> requires the board to adopt the Code of Ethics of the National Association for Rehabilitation Professionals in the Private Sector. <u>Proposed law</u> revises <u>present law</u> to require the board to adopt the Commission on Rehabilitation Counselor Certification Code of Professional Ethics.
