Amendments proposed by Senator Perry to Engrossed Senate Bill No. 120 by Senator Perry

1 AMENDMENT NO. 1

2 On page 1, line 2, after "To" delete "amend and reenact R.S. 13:5554(G)(1) and to"

3 AMENDMENT NO. 2

4 On page 1, line 9, after "Section 1." delete "R.S. 13:5554(G)(1) is hereby amended and
5 reenacted and"

6 AMENDMENT NO. 3

7 On page 1, delete lines 13 through 17

8 AMENDMENT NO. 4

9 On page 2, delete lines 1 through 13

10 AMENDMENT NO. 5

11 On page 2, line 14, after "II." delete the remainder of the line and delete lines 15 through 29
12 and insert the following:

13 **"Notwithstanding the provisions of Subsection D of this Section, the**
14 **sheriff of Vermilion Parish shall pay out of the sheriff's general fund the**
15 **premium costs of group insurance for any retired sheriff and any retired deputy**
16 **sheriff who retires from the Vermilion Parish Sheriff's Office as follows:**

17 **(1) Fifty percent of the premium costs of group hospital, surgical, dental,**
18 **and medical expense and the first ten thousand dollars of life insurance if the**
19 **sheriff or deputy sheriff has at least fifteen years of full-time continuous and**
20 **creditable service with the Vermilion Parish Sheriff's Office and is at least fifty-**
21 **five years of age and is retiring from active service with the Vermilion Parish**
22 **Sheriff's Office. A sheriff or deputy sheriff's creditable days of full-time service**
23 **shall be determined by the Louisiana Sheriff's Pension and Relief Fund.**

24 **(2) One hundred percent of the premium costs of group hospital,**
25 **surgical, dental, and medical expense insurance and the first ten thousand**
26 **dollars of life insurance if the sheriff or deputy sheriff has at least thirty years**
27 **of full-time continuous and creditable service with the Vermilion Parish**
28 **Sheriff's Office, regardless of age. A sheriff or deputy sheriff's creditable days**
29 **of full-time service shall be determined by the Louisiana Sheriffs' Pension and**
30 **Relief Fund."**

31 AMENDMENT NO. 6

32 On page 3, delete lines 1 through 12

1 AMENDMENT NO. 7

2 On page 3, line 13, after "(3)" delete the remainder of the line and delete lines 14 through
3 18 and insert the following:

4 **"The provisions of this Subsection shall apply only to sheriffs and deputy**
5 **sheriffs hired by the Vermilion Parish Sheriff's Office on or after July 1, 2018.**

6 **(4) The provisions of Paragraph (G)(1) of this Section shall apply to**
7 **sheriffs and deputy sheriffs hired by the Vermilion Parish Sheriff's Office prior**
8 **to July 1, 2018."**
