13	A. For purposes of this Section, "agency" means any agency that has an
14	agreement with the Internal Revenue Service to access federal tax information or is
15	authorized by law to audit the records of an agency that has access to federal
16	tax information. "Agency" shall include all of the following:

establish policies with regard to this matter.

- 2 Section 3. This Act shall become effective upon signature by the governor or, if not
- 3 signed by the governor, upon expiration of the time for bills to become law without signature
- 4 by the governor, as provided by Article III, Section 18 of the Constitution of Louisiana. If
- 5 vetoed by the governor and subsequently approved by the legislature, this Act shall become
- 6 effective on the day following such approval.

<u>Present law</u> provides the exclusive list of agencies that may have an agreement with the Internal Revenue Service to access federal tax information.

<u>Proposed law</u> adds the legislative auditor to the agencies that can access federal tax information for purposes of performing audits.

<u>Present law</u> authorizes the legislative auditor to have access to the tax records of the Department of Revenue for purposes of auditing the Department of Revenue.

<u>Proposed law</u> authorizes the legislative auditor to have access to federal tax information and may preform criminal background checks on the auditor's employees who access federal tax information in records of an auditee.

Effective upon signature of the governor or lapse of time for gubernatorial action.
