19 **member of the House of Representatives.**

20 **(20) The president of Xavier University of Louisiana, or his designee.**

21 **(21) The president of Dillard University, or his designee.**

22 **(22) The chairman of the Senate Committee on Education, or his designee.**

23 **(23) The chairman of the House Committee on Education, or his designee."**

4 participation and inclusion of HBCUs at the inception stage and throughout  
5 implementation of economic development activities.

6 (b) Working with the Louisiana Workforce Commission to help identify  
7 educational programs to address workforce gaps.

8 (c) Requesting the Department of Economic Development and the Workforce  
9 Commission to provide periodic updates to the Council on their activities and  
10 initiatives."
