Authorizes electronic delivery of insurance coverage notices

<u>Proposed law</u> authorizes insurers to deliver, store, or present notices and documents in insurance transactions or proof of insurance coverage by electronic means pursuant to the LA Uniform Electronic Transactions Act. <u>Proposed law</u> requires parties receiving insurance documents by electronic means to consent electronically in a manner that demonstrates their ability to receive documents via electronic means. <u>Proposed law</u> requires insurers to provide parties clear and conspicuous statements including certain information prior to parties giving consent. <u>Proposed law</u> requires insurers to take measures to ensure that electronic delivery results in the receipt of documents by the consenting party and that electronic delivery shall have the same effect of any other method required by law. <u>Proposed law</u> applies for applicability of <u>proposed law</u>. <u>Proposed law</u> provides for withdrawal of consent by a party. <u>Proposed law</u> requires alternative delivery methods in certain circumstances. <u>Proposed law</u> limits the civil liability of insurance producers for any harm or injury that occurs because of a party's election to receive documents by a electronic means or by an insurer's failure to deliver documents by electronic means.
