FIRE PROTECT/FIRE MARSHAL: Provides relative to inspections of life safety systems and equipment

AN ACT

2	To amend and reenact R.S. 40:1646(A) and (B) and to enact R.S. 40:1646(E), relative to life
3	safety systems and equipment; to authorize certifications relative to such systems and
4	equipment; to provide for designated representatives; to provide for compliance; to
5	provide penalties for violations; and to provide for related matters.
6	Be it enacted by the Legislature of Louisiana:
7	Section 1. R.S. 40:1646(A) and (B) are hereby amended and reenacted and R.S.
8	40:1646(E) is hereby enacted to read as follows:
9	§1646. State fire marshal; owners; life safety systems and equipment inspections;
10	<u>penalties</u>
11	A. The fire marshal or his designated representative is authorized to cause
12	the inspection, certification, and testing of all life safety systems and equipment in
13	the state, whether in public or private buildings, upon receipt of a complaint, during
14	installation, or immediately after installation to determine compliance with
15	applicable standards.
16	B. The owner of any building containing a life safety system and equipment,
17	or the owner's designated representative, shall cause at a minimum an annual
18	inspection or certification to be made of the life safety system and equipment in that
19	building to assure compliance with applicable safety standards and to determine

Abstract: Authorizes designated representatives to cause certain inspections, testing, and certification of life safety systems and equipment and provides penalties for violations.

<u>Present law</u> authorizes the fire marshal to provide inspections and testing of all life safety systems and equipment in the state of La.

Proposed law retains present law.

<u>Proposed law</u> authorizes the fire marshal's certification of life safety systems. Provides that authorized actions of the fire marshal may be performed upon his receipt of a complaint. Authorizes the fire marshal's designee to perform inspections, testing, and certification.

CODING: Words in struck through type are deletions from existing law; words underscored are additions.

<u>Present law</u> requires the owner of any building containing a life safety system and equipment to have an annual inspection of such system and equipment to assure compliance with applicable safety standards and related matters.

Proposed law retains present law.

<u>Proposed law</u> authorizes the fire marshal to provide certification of life safety systems and equipment within an owner's building. Authorizes the owner's designated representative to provide for the annual inspection or certification.

If an inspecting officer finds that the owner has failed to comply with the provisions of present and proposed law, proposed law requires the officer to order the owner's compliance.

If an inspecting officer finds life safety systems and equipment to be inoperable or not in compliance with applicable safety standards, <u>proposed law</u> requires the inspecting officer to order the owner to have the life safety systems and equipment inspected and brought into compliance with applicable safety standards.

<u>Proposed law</u> provides that persons who fail to comply with an order issued by the fire marshal may be given a warning and ordered to comply with the initial order. Provides that persons who fail to comply with a second order issued by the fire marshal may be fined not more than \$500 or imprisoned for not more than 6 months, or both.

<u>Proposed law</u> authorizes the fire marshal to allow fire prevention bureaus to enforce the provisions of <u>present</u> and <u>proposed law</u>.

<u>Proposed law</u> provides for nothing in <u>present</u> and <u>proposed law</u> to be construed to prevent the fire marshal from enforcing the provisions of present law (R.S. 40:1621).

Summary of Amendments Adopted by House

The Committee Amendments Proposed by <u>House Committee on Commerce</u> to the <u>original</u> bill:

- 1. Provide that a person who fails to comply with an order issued by the fire marshal may be issued a first warning and ordered to comply with the initial order.
- 2. Remove language relative to the fire marshal's authorized representative.
- 3. Give the fire marshal discretion relative to the issuance of criminal penalties for failure to comply with an order.
- 4. Provide that persons who fail to comply with a second order issued by the fire marshal may be fined not more than \$500 or imprisoned for not more than six months, or both.
- 5. Redesignate language relative to the fire marshal's authorization of fire prevention bureaus to enforce the provisions of <u>present</u> and <u>proposed law</u>.
- 6. Provide for nothing in <u>present</u> and <u>proposed law</u> to be construed to prevent the fire marshal from enforcing the provisions of present law (R.S. 40:1621).
- 7. Make technical changes.

The House Floor Amendments to the engrossed bill:

1. Remove language that would constitute each day's violation of an order as separate offense and punishable as such at the court's discretion.
