EDUCATION DEPARTMENT Requires DOE to have an administrative search warrant in order to access video recordings of early learning centers and registered child care providers. (gov sig)

Present law requires the department of education to regularly inspect early learning centers, registered family child care providers, and registered in-home child care providers. Proposed law provides that if, during the course of the investigating a complaint or safety issue, the department seeks access to video recordings made on the premises of such centers and providers, the department may seek an administrative search warrant. Requires that the request for the search warrant be incident specific and include information relative to the date, time, location or persons involved. Effective upon governor's signature.

## **EXPENDITURE EXPLANATION**

There may be an increase in expenses of the department of education (LDE), however amounts are indeterminable at this time. The LDE stated that as there is no precedent for such activities in the department, it is unable to determine the extent of any potential increased staffing needs. In 2017, there were approximately 1,500 licensed centers; 922 complaints were received and investigated, 27 of which included the review of videos. Child care licensing and investigations are funded with federal block grant funding out of the Child Care Development Fund (CCDF). Any increased costs in investigations would reduce available CCDF funds for other expenses.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure.
