HOUSE BILL NO. 489

MOTOR VEHICLES: Requires the Used Motor Vehicle Commission to report information collected by salvage pools and salvage disposal sales

1 AN ACT

2 To enact R.S. 32:808(C) and R.S. 47:1508(B)(42), relative to reporting requirements  
3 imposed on the Louisiana Used Motor Vehicle Commission; to require reporting of  
4 certain information regarding salvage pools and salvage disposal sales; to authorize  
5 the sharing of information; and to provide for related matters.

6 Be it enacted by the Legislature of Louisiana:

7 Section 1. R.S. 32:808(C) is hereby enacted to read as follows:

8 §808. Salvage pools; record keepers

9 \* \* \*

10 C.(1) The commission shall report monthly by electronic mail or any other  
11 reasonable manner to the Department of Revenue the information received during  
12 the prior month from salvage pools or salvage disposal sales pursuant to Subsection  
13 A of this Section.

14 (2) The Department of Revenue, by the discretion of its secretary, is  
15 authorized to share with or furnish to the commission any information either  
16 collected or retained in accordance with the provisions of this Section.

17 Section 2. R.S. 47:1508(B)(42) is hereby enacted to read as follows:

18 §1508. Confidentiality of tax records

1 B. Nothing herein contained shall be construed to prevent:

3 (42) The sharing or furnishing, at the discretion of the secretary, of  
4 information to the Louisiana Used Motor Vehicle Commission pursuant to the  
5 provisions of R.S. 32:808 for the purposes of the collection and retention of registry  
6 information relative to the sale of motor vehicles by the owner, manager, or person  
7 in charge of a salvage pool.

**Abstract:** Requires the La. Used Motor Vehicle Commission to report certain information collected from salvage pools and salvage disposal sales transactions.

Present law (R.S. 32:808(B)) provides that when a bid card is not required in order to purchase a vehicle, a transaction fee of \$5.00 shall be collected and remitted monthly, electronically or otherwise, and transmitted to the commission by the owner or operator of the salvage pool in connection with the sale of each vehicle.

Proposed law retains present law.

Proposed law requires the La. Used Motor Vehicle Commission to report monthly to the Dept. of Revenue (dept.) the information received from salvage pools or salvage disposal sales.

Proposed law authorizes the dept., in the discretion of its secretary, to share with or furnish to the commission any information either collected or retained in accordance with the provisions of proposed law.

Summary of Amendments Adopted by House

The Committee Amendments Proposed by House Committee on Commerce to the original bill:

- 1. Make a technical change.

The House Floor Amendments to the engrossed bill:

- 1. Remove the requirement that the commission send a monthly report of register information to the Department of Revenue.

2. Require the commission to report information received from salvage pools or salvage disposal sales.
3. Remove the requirement that the commission promulgate rules.
