11 AMENDMENT NO. 17

12 On page 8, delete lines 20 through 27 in their entirety and insert the following:

13 "A. A local governmental subdivision that enacted a transportation network
14 company ordinance prior to March 1, 2018, that included a per-trip fee and has a
15 company operating within the corporate limits of the local governmental subdivision
16 as of March 1, 2018, is authorized to impose a fee up to or equal to the per-trip fee
17 imposed by the local governmental subdivision's transportation network company
18 ordinance as of March 1, 2018, on each intrastate prearranged ride originating within
19 the corporate limits of the local governmental subdivision. Nothing in this
20 Subsection shall be construed to allow a local governmental subdivision to impose
21 any fees or requirements other than the per-trip fee specified in this Subsection.

22 B. Any local governmental subdivision not included in Subsection A of this
23 Section is authorized to impose a fee of up to one percent of the gross trip fare for
24 each intrastate prearranged ride. A local governmental subdivision that imposes a
25 per-trip fee pursuant to Subsection A of this Section shall not also impose a fee
26 pursuant to this Subsection. Nothing in this Subsection shall be construed to allow
27 a local governmental subdivision to impose any fees or requirements other than the
28 fee specified in this Subsection.

29 C. A local governmental subdivision authorized to impose a fee pursuant to
30 Subsection B of this Section may impose the specified fee that complies with
31 Subsection B of this Section by passing an ordinance. The ordinance shall impose
32 the specified fee that complies with Subsection B of this Section on each company
33 permitted by the department in accordance with R.S. 45:204. A municipality's fee
34 may only apply to intrastate prearranged rides originating within the incorporated
35 limits of the municipality. A parish's fee may only apply to intrastate prearranged
36 rides originating within the unincorporated portions of the parish."

20 On page 10, at the end of line 2, insert the following: "Any record furnished or disclosed to
21 the department may, as appropriate, exclude information that would identify specific drivers
22 or riders."

23 AMENDMENT NO. 29

24 On page 10, between lines 2 and 3, insert the following:

25 "G. The governing body of a local governmental subdivision may request to
26 review the results of an audit conducted pursuant to Subsection F of this Section with
27 respect to fees remitted by a company to the local governmental subdivision."

28 AMENDMENT NO. 30

29 On page 10, at the beginning of line 3, change "F." to "H."

30 AMENDMENT NO. 31

31 On page 10, line 7, after "Section" delete the remainder of the line and delete lines 8 through
32 12 in their entirety and insert "are designated confidential and are not subject to disclosure
33 to a third party without prior written consent of the company."

2 On page 10, at the beginning of line 13, delete "the company prior to the disclosure."

4 On page 10, line 14, change "Subsection E" to "Subsection F"

15 operations at the airport. An airport pick-up fee is not a local fee subject to the provisions
16 of R.S. 45:215."

18 On page 11, between lines 8 and 9, inset the following:

19 "E. Nothing in this Section may be construed to prohibit the state from
20 maintaining, enforcing, prescribing, or continuing in effect any law or regulation
21 regarding the sale, distribution, repair, or service of vehicles pursuant to Title 32 of
22 the Louisiana Revised Statutes."

23 AMENDMENT NO. 39

24 On page 11, delete lines 9 through 11 in their entirety and insert the following:

25 "Section 2. The department shall also have the authority to promulgate rules
26 and regulations to implement and enforce this Act, including the imposition of fees
27 as are necessary to cover the cost of administration of this Act. The rules and
28 regulations may be more stringent than the requirements set forth in this Act,
29 provided that they are consistent with the requirements of this Act. Additionally, the
30 department shall report to the Joint Legislative Committee on Transportation,
31 Highways and Public Works for review and approval of any rules or regulations
32 promulgated by the department."
