INSURANCE/GROUP-SHERIFFS: Provides relative to sheriffs' retiree health benefits

2	To enact R.S. 13:5554(G)(7), relative to sheriffs; to provide relative to retiree health
3	benefits; to provide for the payment of group insurance premiums for the sheriff and
4	sheriff deputies of East Feliciana Parish; and to provide for related matters.
5	Be it enacted by the Legislature of Louisiana:
6	Section 1. R.S. 13:5554(G)(7) is hereby enacted to read as follows:
7	§5554. Group insurance; kinds; amounts; subrogation

10	(7)(a) The provisions of Paragraph (1) of this Subsection, as applicable to the
11	sheriff's office of East Feliciana Parish, shall apply to sheriffs and deputy sheriffs
12	who were hired prior to July 1, 2018, who meet the eligibility requirements and have
13	the requisite creditable service pursuant to Paragraph (1) of this Subsection.
14	(b) Notwithstanding the provisions of Subsection D of this Section, the
15	sheriff of East Feliciana Parish shall pay out of the sheriff's general fund the
16	premium cost of group hospital, surgical, medical expense, and dental insurance and
17	the first ten thousand dollars of life insurance contracted for under the provisions of
18	this Section shall be paid for any retired sheriff and sheriff deputy who is hired on
19	or after July 1, 2018, as follows:

1	(i) Fifty percent of the premium cost of group hospital, surgical, medical
2	expense, and dental insurance and the first ten thousand dollars of life insurance from

4	Office with fifteen years of creditable service, is at least fifty-five years of age, and
5	is entitled to receive benefits from the Sheriffs' Pension and Relief Fund.
6	(ii) Seventy-five percent of the premium costs of group hospital, surgical,
7	medical expense, and dental insurance and the first ten thousand dollars of life
8	insurance for any sheriff and sheriff deputy who retires from the East Feliciana
9	Parish Sheriff's Office with twenty years of creditable service, is at least fifty-five
10	years of age, and is entitled to receive benefits from the Sheriffs' Pension and Relief
11	<u>Fund.</u>
12	(iii) One hundred percent of the premium costs of group hospital, surgical,
13	medical expense, and dental insurance and the first ten thousand dollars of life
14	insurance for any sheriff and sheriff deputy who retires from East Feliciana Parish
15	Sheriff's Office with twenty-five years of service, is at least fifty-five years of age,
16	and is entitled to receive benefits from the Sheriffs' Pension and Relief Fund.
17	(iv) One hundred percent of the premium costs of group hospital, surgical,
18	medical expense, and dental insurance and the first ten thousand dollars of life
19	insurance for any sheriff and sheriff deputy who retires from East Feliciana Parish
20	Sheriff's Office with thirty years of creditable service and is entitled to receive
21	benefits from the Sheriffs' Pension and Relief Fund.

Abstract: Requires the East Feliciana Parish Sheriff to pay a certain percentage of group insurance premiums for certain retirees.

<u>Present law</u> authorizes the sheriff of each parish to pay for the insurance premiums of the sheriff, sheriff deputies, and dependents of sheriff and sheriff deputies. The sheriff may

contract with any insurance company authorized to do business in this state for group life and accidental death and dismemberment, group health, accident, dental, hospital, surgical, or other medical expense and group disability insurance.

<u>Present law</u> requires the sheriff of certain parishes, including East Feliciana, to pay these premiums in full for their retirees.

<u>Proposed law</u> retains <u>present law</u> for those retirees hired prior to July 1, 2018, and requires the East Feliciana Parish Sheriff to pay the insurance premiums for retired sheriff and sheriff deputies hired on or after July 1, 2018, depending on their years of service:

- (1) Retirees with 15 years of service who have reached 55 years of age shall have 50% of their insurance premiums paid.
- (2) Retirees with 20 years of service who have reached 55 years of age shall have 75% of their insurance premiums paid.
- (3) Retirees with 25 years of service who have reached 55 years of age shall have 100% of their insurance premiums paid.
- (4) Retirees with 30 years of service at any age shall have 100% of their insurance premiums paid.
