### RETIREMENT/REGISTR VOTER: Provides for the repayment of refunded contributions by a member of the Registrars of Voters Employees' Retirement System

1	AN ACT
2	To amend and reenact R.S. 11:2075, relative to the repayment of contributions by a member
3	of the Registrars of Voters Employees' Retirement System; to allow a former
4	member to repay withdrawn contributions upon return to the system; and to provide
5	for related matters.
6	Notice of intention to introduce this Act has been published
7	as provided by Article X, Section 29(C) of the Constitution
8	of Louisiana.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. R.S. 11:2075 is hereby amended and reenacted to read as follows:
11	§2075. Return of accumulated contributions
12	If a member ceases to be an employee, except by death or retirement under the
13	provisions of this Chapter, he shall be paid such part of the amount of the accumulated
14	contributions standing to the credit of his individual account in the annuity savings fund as
15	he shall demand. If a member dies before retirement, the amount of his accumulated
16	contributions standing to the credit of his individual account shall be paid to his estate or to
17	such person as he shall have nominated by written designation, duly executed and filed with
18	the board of trustees. If an employee returns to membership in the system after withdrawing
19	his contributions and remains a contributing member for four years, he then shall be entitled
20	to may repay the amount which he withdrew, plus interest at a rate determined by the board

Abstract: Allows a member of the Registrars of Voters Employees' Retirement System (ROVERS) to repay withdrawn contributions upon return to membership in the system.

<u>Present law</u> allows a member of ROVERS who ceases to be an employee, except by death or retirement, to withdraw the amount of the accumulated contributions standing to his credit upon demand. <u>Present law</u> further allows a former member who withdrew his contributions and who returns to membership in the system to repay the amount he withdrew, plus interest, in exchange for credit for the service he forfeited at the time he withdrew but only after remaining a contributing member for four years.

<u>Proposed law</u> allows a former member who returns to membership in the system after withdrawing his contributions to repay the withdrawn amount as provided by <u>present law</u> immediately upon return to membership in the system.

Effective July 1, 2018.
