2	To amend and reenact R.S. 11:1760(A)(introductory paragraph) and to enact R.S. 11:1789.6
3	and 1808.6, relative to members of the Tier 2 plans of the Municipal Employees'
4	Retirement System of Louisiana; to provide for the vesting period of such members;
5	and to provide for related matters.
6	Notice of intention to introduce this Act has been published
7	as provided by Article X, Section 29(C) of the Constitution
8	of Louisiana.
9	Be it enacted by the Legislature of Louisiana:
10	Section 1. R.S. 11:1760(A)(introductory paragraph) is hereby amended and
11	reenacted and R.S. 11:1789.6 and 1808.6 are hereby enacted to read as follows:
12	§1760. Vesting
13	A. A Except as provided in R.S. 11:1789.6 or 1808.6, a member who
14	withdraws from active service on or after the revision date prior to becoming eligible
15	for retirement, having at least ten years of creditable service, and having received no
16	refund of his accumulated contributions, shall be entitled to receive a retirement
17	allowance to commence on his earliest normal retirement date.

19	<u>§1789.6. Vesting</u>
20	A. A member of MERS Plan A Tier 2 who withdraws from active service
21	prior to becoming eligible for retirement, who has at least seven years of creditable

1	service, and who has received no refund of his accumulated contributions, shall
2	receive a retirement allowance to commence on his earliest normal retirement date.
3	(1) Such deferred retirement allowance shall be computed according to the
4	provisions of this Part based on final compensation and creditable service at date of
5	withdrawal.
6	(2) During the period from the member's date of withdrawal from service to
7	the member's earliest normal retirement date, he shall not be considered a member
8	and therefore shall not be entitled to any benefits due a member. Upon retirement
9	he may exercise all rights and privileges of a retired member.
10	B. Should a vested terminated member return to active employment, he shall
11	become a member and shall contribute at the current contribution rate.

13	§1808.6. Vesting
14	A. A member of MERS Plan B Tier 2 who withdraws from active service
15	prior to becoming eligible for retirement, who has at least seven years of creditable
16	service, and who has received no refund of his accumulated contributions, shall
17	receive a retirement allowance to commence on his earliest normal retirement date.
18	(1) Such deferred retirement allowance shall be computed according to the
19	provisions of this Part based on final compensation and creditable service at date of
20	withdrawal.
21	(2) During the period from the member's date of withdrawal from service to
22	the member's earliest normal retirement date, he shall not be considered a member
23	and therefore shall not be entitled to any benefits due a member. Upon retirement
24	he may exercise all rights and privileges of a retired member.
25	B. Should a vested terminated member return to active employment, he shall
26	become a member and shall contribute at the current contribution rate.

1	Section 2. This Act shall become effective on July 1, 2018; if vetoed by the governor
2	and subsequently approved by the legislature, this Act shall become effective on July 1,
3	2018, or on the day following such approval by the legislature, whichever is later.
