1 AMENDMENT NO. 1

2 On page 1, line 2, change "13:5109(B)(3) through (5)," to "Subpart L of Part II-A of Subtitle  
3 I of Title 39 of the Louisiana Revised Statutes of 1950, to be comprised of R.S. 39:100.36,"

4 AMENDMENT NO. 2

5 On page 1, line 3, after "state;" and before "to provide" insert the following:

6 "to provide for the creation of the Payment of Judgments Fund; to provide for the  
7 deposit, investment, and use of monies in the fund;"

13 AMENDMENT NO. 4

14 On page 1, delete lines 10 through 13, and insert the following:

15 **SUBPART L. PAYMENT OF JUDGEMENTS FUND**

16 **§100.36. Payment of Judgements Fund; order of payment of judgments**

17 **A. The "Payment of Judgments Fund", hereinafter referred to as the**  
18 **fund, is hereby created in the state treasury. Interest earned on the investment**  
19 **of monies in the fund shall be deposited in and credited in the fund.**  
20 **Unexpended and unencumbered monies in the fund at the close of each fiscal**  
21 **year shall remain in the fund. Monies in the fund shall be appropriated,**  
22 **administered, and used solely and exclusively for the purpose of satisfying final**  
23 **nonappealable judgments and compromises against the state as further**  
24 **provided in this Section.**

25 **B. The fund shall be comprised of all monies appropriated, donated, or**  
26 **otherwise made available to provide funding to satisfy and pay judgments**  
27 **against the state. All of such monies required to be deposited in the state**  
28 **treasury in accordance with Article VII, Section 9(A) of the Constitution of**  
29 **Louisiana shall be deposited in the fund after first meeting the requirements of**  
30 **Article VII, Section 9(B) of the Constitution of Louisiana relative to the Bond**  
31 **Security and Redemption Fund.**

32 **C. Annually, the Office of Risk Management shall notify the**  
33 **commissioner of administration of all final nonappealable judgments and**  
34 **compromises which cannot be paid from the Self-Insurance Fund as of**  
35 **December thirty-first. The governor may then include in the executive budget**  
36 **an amount sufficient to pay such judgments or compromises, including judicial**  
37 **interest and costs. The legislature may appropriate into the fund such monies**  
38 **as it deems necessary and appropriate to pay such judgments."**
