2	To enact R.S. 49:191(10)(c) and to repeal R.S. 49:191(8)(l), relative to the Department of
3	Environmental Quality, including provisions to provide for the re-creation of the
4	Department of Environmental Quality and the statutory entities made a part of the
5	department by law; to provide for the effective termination date for all statutory
6	authority for the existence of such statutory entities; and to provide for related
7	matters.
8	Be it enacted by the Legislature of Louisiana:
9	Section 1. Pursuant to R.S. 49:193, the Department of Environmental Quality and
10	the statutory entities made a part of the department by law shall be re-created effective
11	June 30, 2018, and all statutory authority therefor is continued in accordance with the
12	provisions of Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of 1950.
13	Section 2. All statutory authority for the existence of the Department of
14	Environmental Quality and the statutory entities made a part of the department as re-created
15	by Section 1 of this Act shall cease as of July 1, 2023, pursuant to R.S. 49:191. However,
16	the Department of Environmental Quality may be re-created prior to such date in accordance
17	with the provisions of Part XII of Chapter 1 of Title 49 of the Louisiana Revised Statutes of
18	1950.
19	Section 3. The provisions of R.S. 49:193 are hereby superseded to the extent that
20	those provisions are in conflict with the provisions of this Act.
21	Section 4. R.S. 49:191(10)(c) is hereby enacted to read as follows:
22	§191. Termination of legislative authority for existence of statutory entities;
23	phase-out period for statutory entities; table of dates
24	Notwithstanding any termination dates set by any previous Act of the
25	legislature, the statutory entities set forth in this Section shall begin to terminate their
26	operations on July first of each of the following years, and all legislative authority

1	for the existence of any statutory entity, as defined in R.S. 49:190, shall cease as of
2	July first of the following year, which shall be the termination date:

7	made a part of the department by law.
8	Section 5. R.S. 49:191(8)(1) is hereby repealed.
9	Section 6. This Act shall become effective on June 30, 2018; if vetoed by the
10	governor and subsequently approved by the legislature, this Act shall become effective on
11	June 30, 2018, or on the day following such approval by the legislature, whichever is later.
