 Creates the Healthy Moms, Healthy Babies Advisory Council

Proposed law creates the Healthy Moms, Healthy Babies Advisory Council and places it within the LA Dept. of Health. Proposed law provides for the council's duties and membership and requires the Secretary of LDH to convene the council's initial meeting on October 1, 2018 and at least quarterly thereafter. Proposed law states that members of the council shall serve without compensation. Proposed law requires LDH staff to support the council. Proposed law requires the council to perform certain duties, including issuing a report of its findings no later than February 1, 2020. Proposed law creates a public records exception associated with records of the council. Proposed law allows for the publication of certain data which do not identify any individual persons. Proposed law terminates on March 31, 2021.
