 and shall not be subject to the provisions of this Chapter.
 - (c) Nothing in this Chapter shall be construed to authorize any person licensed, certified, provisionally certified, or registered hereunder to prescribe, either orally or in writing, distribute, dispense, or administer any medications. Nothing in this Chapter shall be construed to authorize any social worker licensed, certified, provisionally certified, or registered under this Chapter to administer or interpret psychological tests, or to engage in the practice of psychology, as defined by the

1	provisions of R.S. 37:2352(5) or to engage in the practice of medicine, as defined by
2	the provisions of R.S. 37:1262. Notwithstanding any provisions of R.S. 37:2352(5),
3	persons covered by this Chapter may, based upon scope of practice, administer, use,
4	or interpret tests of language, education and achievement, adaptive behavioral tests,
5	and symptom screening checklists instruments, as well as tests of abilities, interests,
6	and aptitudes.

8	§2709. License, certification, or registration required
9	A. No individual shall practice social work in the state unless the individual
10	holds a current, valid license, certificate, or registration issued by the board in
11	accordance with this Chapter. This license, certificate, or registration shall be kept
12	conspicuously posted in the office or place of business at all times.
13	B. An individual shall submit an application for licensure, certification,
14	or registration to the board within ninety days of commencement of social work
15	practice."
