Amendments proposed by Representative Jay Morris to Engrossed House Bill No. 833 by Representative Jay Morris

1 AMENDMENT NO. 1

2 On page 1, line 2, after "R.S. 3:227," and before "R.S. 11:544(B)(3)(a)," insert "R.S.
3 4:217(D)(1),"

4 AMENDMENT NO. 2

5 On page 2, between lines 11 and 12 insert the following"

6 "Section 2. R.S. 4:217(D)(1) is hereby amended to read as follows:

§217. Purse supplements; designation and distribution

9 * * *

10 D.(1) Notwithstanding any other provision of law to the contrary, the monies
11 designated for purses under the provisions of R.S. 4:216(C) from wagers placed at
12 offtrack wagering facilities on special accredited Louisiana bred maiden races as
13 defined in R.S. 4:184 shall be accounted for separately and shall be distributed as
14 follows:

16 (a) Seven and five tenths ~~Fifteen and ten hundredths~~ percent shall be
17 distributed to the Louisiana Thoroughbred Breeders Association for breeder awards
18 in accordance with a distribution formula established by the executive committee of
19 that organization.

20
21 (b) Twenty and seventy-five ~~Forty-one and forty-five~~ hundredths percent
22 shall be distributed to the host track for purse supplements for the special accredited
23 Louisiana maiden thoroughbred races held at that track.

24
25 (c) Twenty and seventy-five ~~Forty-one and forty-five~~ hundredths percent
26 shall be distributed to the tracks owned by the licensee(s) of the offtrack wagering
27 facility where the wagers are made for purse supplements for the special accredited
28 Louisiana bred maiden thoroughbred races held at their respective tracks.

30 (d) One ~~Two~~ percent shall be distributed to the Horsemen's Benevolent and
31 Protective Association for the use and benefit of such persons and other horsemen
32 as medical and hospital benefits with an amount not to exceed thirty percent thereof
33 to be used for administrative expenses and other costs necessary to provide the
34 benefits.

36 (e) Fifty percent shall be transferred to the state treasury to be deposited in
37 and credited to the Hospitals and TOPS Stability Fund."
