

SENATE COMMITTEE AMENDMENTS

2018 Regular Session

Amendments proposed by Senate Committee on Labor and Industrial Relations to Reengrossed House Bill No. 830 by Representative Stokes

1 AMENDMENT NO. 1

2 On page 3, delete lines 8 through 22 and insert the following:

3 "(6) "Employee" means any individual who is employed by a sexually
4 oriented business for remuneration under any contract for hire but does not include
5 an independent contractor.

6 (7) "Independent contractor" means an individual who contracts to perform
7 services for a sexually oriented business on a non-exclusive basis under a written
8 agreement specifying that the individual is a contractor and not an employee of the
9 sexually oriented business.

10 (8) "Nudity" means the showing of the human male or female genitals, pubic
11 area, vulva, or anus with less than a fully opaque covering, or the showing of the
12 female breasts with less than a fully opaque covering of any part of the nipple or
13 areola.

14 (9) "Operator" means any individual who is on the premises of a sexually
15 oriented business who causes the business to function or who puts or keeps in
16 operation the business or who is authorized to manage the business or exercise
17 overall operational control of the business premises."

18 AMENDMENT NO. 2

19 On page 3, line 23, change "(9)" to "(10)"

20 AMENDMENT NO. 3

21 On page 3, between lines 27 and 28, insert the following:

22 "(11) "Semi-nude" or "semi-nudity" means the showing of the female breasts
23 below the horizontal line across the top of the areola and extending across the width
24 of the breasts at the point, or the showing of the male or female buttocks. This shall
25 include the lower portion of the human female breast but shall not include the
26 cleavage of the human female breast exhibited by a bikini, dress, shirt, blouse,
27 leotard, or similar wearing apparel provided the areola is not exposed in whole or in
28 part.

29 (12) "Specified anatomical area" means any of the following:

30 (a) Less than completely and opaquely covered human genitals or pubic
31 region.

32 (b) Less than completely covered buttock.

33 (c) Less than completely covered female breast below a point immediately
34 above the top fo the areola.

35 (d) Human male genitals in a discernibly turgid state, even if completely and
36 opaquely covered.

37 (13) "Specified sexual activity" means any of the following:

38 (a) Intercourse, oral copulation, masturbation, or sodomy.

39 (b) Excretory functions as a part of or in connection with any of the activities
40 described in Subparagraph (a) of this Paragraph."

41 AMENDMENT NO. 4

42 On page 4, delete lines 10 and 11 and insert the following:

43 "in combination with one United States Citizenship and Immigration Services Form
44 I-9 List C document."
