## **EXPENDITURE EXPLANATION**

There is no anticipated direct material effect on governmental expenditures as a result of this measure. The John J. Hainkel, Jr., Home & Rehabilitation Center is a state-owned facility leased and operated by the New Orleans Home for the Incurables and overseen by the LA Dept. of Health, Office of Aging and Adult Services (OAAS). Staff at OAAS do not anticipate that <a href="mailto:proposed law">proposed law</a> will affect operations of the facility, as the Hainkel Home currently provides adult day health care services. Therefore, the proposed law does not have an anticipated impact on expenditures.

## **REVENUE EXPLANATION**

There is no anticipated direct material effect on governmental revenues as a result of this measure. Staff at the LA Dept. of Health, Office of Aging and Adult Services (OAAS) do not anticipate the proposed legislation to affect lease agreements between OAAS and the lessee of the facility, nor is it anticipated to affect lease payment revenues. For reference, OAAS receives lease payment revenues from the lessee, which are then classified and appropriated as self-generated revenues.
